At the outset, the newly appointed Vice-Chancellor Prof. (Dr.) Vijay Kayatwas introduced to the house and after formal introduction of all the members, the Vice-Chancellor welcomed the members of the Executive Council. The house noted and applauded the appointment of the Vice-Chancellor made vide letter No.HRB-UA-26(2)-2016/10364 dated 23.12.2016 of Governor – Chancellor and his joining on 23.12.2016. Thereafter, the formal agenda was taken up item wise and resolved as under:

- 1. Confirmed the minutes of the 49<sup>th</sup> meeting of the Executive Council held on 13.07.2015. While confirming the minutes, Prof. Monika Verma raised the issue regarding resolution no. 59 of the 49<sup>th</sup> meeting and the house resolved to authorize the Vice-Chancellor to get the matter examined and to take action accordingly.
- 2. Confirmed the minutes of the 50<sup>th</sup> meeting of the Executive Council held on 30.07.2016.
- 3. Noted the follow up action on the decisions taken in the 49<sup>th</sup> meeting of the Executive Council held on 13.07.2015.
- 4. Noted the follow up action on the decisions taken in the 50<sup>th</sup> meeting of Executive Council held on 30.07.2016.
- 5. Considered and approved the Annual Report of Chaudhary Devi Lal University, Sirsa, for the calendar year 2016.
- 6. Considered and approved the Budget Estimates of Chaudhary Devi Lal University, Sirsa for the Financial Year 2017-18 and Revised Budget Estimates for the Financial Year 2016-17 duly approved by the Vice Chancellor as per resolution No.3 of the minutes of the Finance Committee meeting dated 28.03.2017, circulated vide No. CDLU/Acc./FC/17/3026-34 dated 30.03.2017.
- 7. Considered and approved the Balance Sheet on the Accounts of Chaudhary Devi Lal University, Sirsa for the financial year 2015-2016.
- 8. Considered and approved the Annual Audit Report on the Accounts of Chaudhary Devi Lal University, Sirsa for the financial year 2015-2016. Further, the house resolved that a special campaign be started for settlement of old temporary advances, paras and requisitions, and especially to examine the issue related to advances standing against Prof. Balbir Singh.
- 9. Noted the action taken by the Vice Chancellor under Section 11 (6) regarding approval of Ordinance for M.Phil. courses under Choice Based Credit System (CBCS).
- 10. Noted the action taken by the Vice Chancellor under Section 11 (6) of the University Act regarding approval of head wise division of Fee for the courses being run in University Teaching Departmentsw.e.f. the session 2016-17.

- 11. Noted the action taken by the Vice Chancellor under Section 11 (6) for approval of minutes of the meeting of the Fee Committee regarding rules/procedure of admission and fee structure of 2nd year B.Ed. course.
- 12. Noted the action taken by the Vice Chancellor under Statute 23(4) of Act of this University for engagement of Sh. A.K. Modi, (Retd.) Chief Engineer, PWD B&R as Technical Advisor. Further, his representation regarding increase in remuneration was considered (placed on table) and resolved to follow the rules of K.U.K. regarding remuneration as well as terms and conditions of appointment of Technical Advisor w.e.f. 1<sup>st</sup> April, 2017. Further, resolved that the present term of Sh.A.K. Modi is upto 29.06.2017, that may be extended for further six months if the rules so permit, otherwise fresh process be initiated as per K.U.K. rules.
- Considered and approved the grant of Senior Scale of Rs. 10000-325-15300 (prerevised) to Dr. Vikas Panwar w.e.f. 01.08.2008.
- 14. Noted the amended qualifications of the State Government for the appointment of Asstt. Professors/Librarian in Universities and Colleges. Further, resolved that such type of qualifications/criteria as received from the State Govt. be adopted as such, as and when received from time to time.
- 15. Considered and approved the matter regarding withdrawal of Senior Scale granted to Dr. Dilbag Singh w.e.f. 02.12.2005 on completion of five year service and granting the same after six year service as per State Govt. norms. Further, the case of recovery of excess amount received by him on this account be examined legally and the action be taken as per rules.
- 16. Considered the inquiry report in case of admission of a student named Ms. Gunia Rani D/o Sh. Surinder, Department of Chemistry, which is not on merit and it was resolved to issue a charge-sheet to Dr. Geeta Rani, Assistant Professor.
- 17. Noted the action taken by the Vice-Chancellor under Section 23(4) of Statutes of this University for engagement of Sh. Himmat Singh as Security Consultant on contract basis.
- Considered and approved the amendment in Ordinance for lateral entry admission in M. Sc. Mathematics 5 year Integrated Course.
- 19. Considered and approved the recommendations of the Academic Council vide Resolution No. 63 of its 22nd meeting held on 15.02.2017 regarding amendment in the Ordinance of M. Sc. (Hons.) Economics 5 year Integrated Course including the Ordinance for lateral entry admission in M.A. Hons. (Economics).
- Considered and approved the Rules & Regulations regarding Leave and Tour of the Vice-Chancellor of the University.
- 21. Considered and approved the recommendations of the Academic Council meeting held on 15.02.2017 vide which the MoU with INFLIBNET regarding membership of Shodhganga was allowed to be signed in anticipation approval of the Academic Council and the Executive Council as per its resolution No. 41.

- 22. Considered the issue of non-payment with regard to encashment of Bank Guarantee by The Sirsa Central, Cooperative Bank Ltd. of the outsourcing agency i.e. "The SirsaBansivat CO-OP L/C Society Ltd., Sirsa and resolved as under:
  - a. Action taken by the Vice-Chancellor on this pretext for surplus funds is approved.
  - b. Correspondence be made with the Higher Authorities of the Bank apprising the complete situation and loss caused to the University due to this lapse.
  - c. Surplus funds of the University be deposited in the form of FDRs as per the rules/procedure of the University.
- 23. Noted the action taken by the Vice-Chancellor under Section 11(6) of the University Act in allowing deputation and further extension to Dr. Maya Devi, Assistant Librarian of this University as Deputy Librarian to Gautam Buddha University, Greater Noida.
- 24. Noted the action taken by the Vice-Chancellor under section 11(6) of the University Act regarding the payment of Leave Encashment to Sh. Ramesh Kumar Mehta, Ex-Deputy Registrarin compliance of the orders of the court of Additional District Judge, Sirsa.
- 25. Noted the action taken by the Vice-Chancellor under section 11(6) of the University Act to allow deputation, and approved the extension for further one year w.e.f. 19.08.2016 to 18.08.2017-case of Ms. SakshiDhingra, Assistant Professor, Department of Computer Science & Engineering, Guru Jambheshwar University of Science & Technology, Hisar, to this University. Further, her parent University and the candidate be asked to supply the terms and conditions of her deputation at the earliest.
- 26. Noted the resolution of Academic Council taken vide resolution No. 25 & 26 in its meeting held on 15.02.2017 according to which the Vice-Chancellor has been authorized to constitute a committee for framing the policy to deal with such issues.
- 27. Noted the continuation of the services of Assistant Professor (Contractual) working in the University Teaching Departments and to maintain the status quoas on dated 30.05.2016 in compliance of orders of the Hon'ble Punjab & Haryana High Court, till further orders.
- 28. Considered the request of Prof. RaghuvendraTanwar, Convener of the Committee constituted by the Executive Council in its 49th meeting held on 06.07.2016 for reviewing the issues relating to the non-teaching employees and authorized the Vice-Chancellor to constitute a fresh committee to review the subject matters of the earlier committee except the matter of promotion channels of the Non-Teaching Staff.

46.
