
THE TORCH BEARER (25th September, 1914 – 6th April 2001)

Chaudhary Devi Lal University, Sirsa is named after Jan Nayak Chaudhary Devi Lal, the former Deputy Prime Minister of India and the former Chief Minister of Haryana.

Ch. Devi Lal was a veteran freedom fighter, a crusader against the British Raj and a symbol of patience and fortitude. He proved himself to be a man of action, be it in the freedom movement or the post-independence amelioration of the plight of the suffering peasantry. He was looked upon with love and affection during his younger days and with reverential awe in his later life, when he was popularly nicknamed "Tau". The welfare of the people was a mission with Chaudhary Devi Lal, who strove hard to see the peoples' power reflected in the peoples' rule. He was committed to the development of the backward classes, which included farmers, the oppressed and women. He always wanted the present education system to impart true knowledge. He firmly held that 'true Swaraj' means participation of the poor, illiterate, underprivileged and millions living in our villages. As the Deputy Prime Minister of India and being one of the architects of the state of Haryana, he took many steps for the agricultural development. His services to Haryana and the country are indeed unforgettable. As reverently called 'Tau', the Jan Nayak, a 'Karmayogi' and a 'Colossal' guide Ch. UNIVERSITY AT A GLANCE

Established on 2nd April, 2003, CDLU, Sirsa is named after Jan Nayak Chaudhary Devi Lal, the former Deputy Prime Minister of India and the former Chief Minister of Haryana. This University, set up by the Government of Haryana under Act 9 of 2003 passed by the State Legislature, has a sprawling campus of 213 Acre, 4 Kanal, 12 Marla at Barnala Road, Sirsa.

The university has four Teaching Blocks, well-equipped labs, Vivekananda Library, five well-furnished hostels for boys and girls, Media Centre with a Community Radio Station, a majestic Multi-Purpose Hall and auditorium, Shopping Complex, University Health Centre and the branch of a nationalized bank, Guest House, Vice Chancellor's residence and 144 houses for the teaching and non-teaching staff. Fifth teaching block is near completion, besides extension of other buildings.

The main objective of the University is to facilitate, promote and excel in Higher Education, Research and Consultancy in the conventional as well as emerging areas of knowledge. To enhance the standard of higher education and increase the research activities the University has been connected to National Knowledge Network (NKN) provided through one GBPS (optical fiber) dedicated line under NMEICT project of Ministry of HRD India. Wi-Fi facility has also been provided in the University campus. Duringthe lock down and in the post lock down period the university has adopted online mode of teaching. The process of admission is also online and to ensure the health hazards of the prospective students, the admission process has been simplified and it is expected that the students will be self-accountable in furnishing the relevant information and will enter into academic programmes in full earnestness and with integrity for self-enrichment.

The university at present has (approx.) **61** colleges affiliated to it. The total enrollment of students in UTDs, University College, USGS and Affiliated Colleges crosses 42000.

29 Teaching Departments in the University offers 37 academic programmes under budgeted mode and Self Financing System and University School for Graduate Studies offers 12 programmes as per NEP-2020 in the area of Technology, Management, Commerce, Law, Journalism and Mass Communication, Humanities, Social Sciences, Science and Education. Well-known, reputed and experienced academicians and professionals have been associated in preparing the academic curriculum of different programmes as per the guidelines of the UGC and other regulatory bodies. Teachers of the university have wide national and international exposure.

The emphasis is to impart quality education by providing congenial and liberal atmosphere in the campusthrough the promotion of extracurricular activities. Sports events at university, state, North Zone and All India Intervarsity level are organized. Students also participate in Youth Festivals at University, State, North Zone and All India level. NSS and Red Cross etc. provide scope for extension activities. Thus the university prioritizes to enable students achieve overall growth of their personality as professionals and humans.

University Vivekananda Library is well stocked with more than 1 lac quality books and journals. Students can access e-books and e-journals through REFREAD through online resources. The reading rooms in the University Library are open for students to study during night under normal conditions.

The University has adopted innovative methods in conducting University examinations. The students of this University have shown commendable results in academics as well as co-curricular activities. With the present pace of progress already acquired, the University looks forward to having a promising future.

The university has signed MOUs with foreign governments/educational institutions in

accordance with the national drive for the internationalization of Indian higher education. The mission is to inculcate productive quality among the students who will strive for the upliftment of humanity at large.

UNIVERSITY SCHOOL FOR GRADUATE STUDIES (USGS)

The Department is having separate building only for law students namely Dr. Ambedkar Bhawan (Teaching Block 3). Separate air conditioned library with E- journals, moot court hall, separate common rooms for boys and girls, smart class room, lecture theatres are the features of the department building. The department is having experienced faculty in law and pre law subjects. The Department of Law prepares lawyers leaders to serve the community through meticulously designed legal education, experiential training and professional identity formation with inan inclusive environment.

UNIVERSITY CENTRE FOR OUTREACH PROGRAMS AND EXTENSION (UCOPE)

Ambitious Metamorphosis of the University can be achieved by way of establishing a couple of Special Purpose Vehicles (SPVs); one of them is the University Centre for Outreach Programs and Extension (UCOPE) which has been recently established in Teaching Block-IV (Dr. APJ Abdul Kalam Bhawan) of the university.

The COPE envisions to use education and technology for:

- Inculcating basic skills among students;
- Facilitating avenues for training and placement of the students;
- Conducting Outreach and Extension programmes by undertaking training and consultancy services;
- Setting up Centres for focus areas like Gender Studies, Rural Development etc. and Chairs in thename of Celebrated leaders.
- All activities that have hitherto called extracurricular and co-curricular, the academic aspects of such activities will be managed by UCOPE.

The Centre will fill up the gap of skill enrichment and university extension and outreach endowment asenvisaged in NEP-2020.

UNIVERSITY CENTRE FOR RURAL STUDIES (UCRS)

Chaudhary Devi Lal University Sirsa is located in the rural hinterland and therefore considered to be educationally backward. The economic life of the university's catchment area in the Sirsa and Fatehabad districts (the colleges of these districts are affiliated to this University) of Haryana state, Bhatinda, Mansa and Barnala districts of Punjab state and Hanumangarh and Sri Ganga Nagar districts of Rajasthan primarily dependents upon on agriculture activities. The rural demographic character of the University necessitates conducting and promoting studies in rural affairs. Thus, the rationale for setting up the University Centre for Rural Studies. The Centre will be headed by a Director (equivalent to the rank of Professor and should have experience of rural affairs related research studies) with adequate staff and own office. The UCRS will:

- a) Prepare, develop and deliver academic programs focusing on rural affairs.
- b) Promote research in rural affairs.
- c) Institute award for excellent research work in rural affairs.
- d) Conduct training programs for elected representatives of PRIs and officials engaged indelivering services to rural people or engaged in rural development.

VIVEKANANDA LIBRARY

Vivekananda Library came into existence in the year 2003. At present, it has an impressive four storey building. The present building of library is easily approachable. Beautiful lawns, add to its grandeur. Special attention is given to the facilities of drinking water, light system and security system. Fully Air Conditioned 3 Reading Halls (24x7) and 3 Reading Halls with stack area, Computer Lab, Periodical Section and Thesis Section for Ph.D. Scholars. All the reading areas of the Library are spacious, peaceful and well furnished with comfortable furniture. The Library is having rich collection of publications which include books, journals, thesis/dissertations, reports, newspapers and magazines etc.

The Library at present has a total collection of 1,13,449 books, lots of e-Journals are available through REFREAD, 895 Thesis and Dissertation, 2131 Reference books, 550 books in regional languages, 560 books for competitive examination, 270 old question paper set in paper bank, 8 Magazines, 1 Discovery Science Magazine and 15 newspapers to cater to the needs of the users. The Library also provides Reference Books including Encyclopedia, Dictionary etc. The SC/ST Book Bank with collection of 2837 books exists in the library for SC/ST students of various departments. The facility of online Journals and database is being provided to the users by INFLIBNET through UGC Infonet Digital Library Consortium Shodh Sindhu. Inter Library Loan facility is also available through DELNET. The Wi-Fi internet connectivity is available in the Library for easy access of internet services. Further, there is an access to E-books within University campus. The concept of fully automation of Library is adopted by the Vivekananda Library.

HOSTELS

At Present, there are five hostels-three for girls and two for boys, namely, Harki Devi Bhawan (Girls' Hostel-I), Kalpana Chawla Bhawan (Girls' Hostel-II), Savitri Bai Phulle Bhawan (Girls' Hostel-III), Lala Lajpat Rai Bhawan (Boys' Hostel-I) and Sardar Patel Bhawan (Boys' Hostel-II with extension). All the five hostels have been provided with tube/LED lights and ceiling fans in every room. Solar panels are also installed at roof top of all these hostels. Electric geysers have been installed in bathrooms. Water coolers with RO system have also been provided. The hostels subscribe several national and regional magazines and newspapers for enabling the students to know what is happening around the world. The facility of 32ll Plasma TVs alongwith Dish/DTH facility has been provided in common rooms of all the

hostels. Full A.C. reading hall is available for all girls in Girls Hostel-III. Medical facilities to all hostel residents are provided through the university Health Centre located in University premises. Washing machine facility is also available in Girls Hostel. Besides, one ANM and Ambulance facility has also been provided for the girl residents.

The Chief Warden, along with all Wardens, makes every possible effort to see that the students get a cleaner surrounding within and outside the hostel premises, get hygienic food and always respond to the complaints of hostel residents in a positive manner. A total number of 38 benches (Three-seater each) have been provided in the premises of Girl's and Boy's Hostels separately. In the premises of both Girls Hostels, two separate lawns have been developed and Badminton Courts has also been constructed in four hostels. In Girl's Hostels, the facility of Table Tennis & Badminton and in Boy's Hostels, the facility of Table Tennis, Badminton and Volleyball has also been provided. The Gymnasium facility has been provided in the Hostels. E-rickshaw facility has also been provided for the residents of the hostels.

UNIVERSITY IT & DATA CENTRE (UCC & WEBSITE OFFICE)

IT Facilities and Infrastructure:

1. Internet Connectivity (Lease Lines)

The University has procured the following two (02) different dedicated Internet Lease Lines for uninterrupted and 24 x 7 internet access for its stakeholders:

- i) Dedicated Lease Line (1:1) provided by National Knowledge Network (NKN) with **1 Gbps** bandwidth since 2011.
- ii) Dedicated Lease Line (1:1) procured by University with **500 Mbps** bandwidth from RailtelCorporation of India w.e.f. 08.07.2021 for 3 years.

2. Networking

UITDC has established a University-wide Local Area Network (LAN) and W-LAN/Wi-Fi for providing internet facilities to all stakeholders. An optical Fiber-based LAN setup is having approximately 400 nodes. Wi-Fi connectivity is available 24x7 in all buildings with 411 Access Points.

University has Data Centre/Server Room with high-end and latest configuration servers with uninterrupted power supply for various IT projects like Examination System, Online Admissions, University Website, Digital Library etc.

UITDC prefers the latest and next-generation IT tools and gadgets such as firewalls, L-3/L-2 switches, managed switches, routers, bridges, log servers, etc. for upgrading the existing IT infrastructure.

3. Internet Access

University has recently upgraded the Software-based firewalls by procuring Hardware-based Next- Generation Firewalls to provide a safe, secure and restricted internet browsing environment. UITDC is providing two-tier authentication to all internet users of the University to avoid unauthorized access and misuse of the internet. Each internet user is being allotted a unique user ID and password.

4. Webmail Services

University has subscribed to Google Workspace for Education Fundamentals for facilitating its stakeholders for smooth functioning of teaching-learning processes, online meetings, webmail services for official correspondence, and free data storage/cloud service to store important files, documents, etc

In addition to above, the establishment of three (3) Computer Labs having 113 Nos. of desktop computers with LAN & Wi-Fi connectivity, adequate furniture and sufficient power backup in the Dr. APJ Abdul Kalam Bhawan isunder process.
- 7. University Website: The University Website (www.cdlu.ac.in) is being maintained and updated efficiently, effectively and promptly by the University Website Office. Being very descriptive and informative, the number of global visitors on the University website is increasing day by day. Further, this office has initiated the process of strengthening the website accessibility.
- **8. Social Media:** The social media pages/accounts such as Facebook, Twitter, LinkedIn have been created for sharing the required day-to-day activities & important information and linked with University Website at the Home page tab –follow us ||.
- **9. Online Admission:** The University has started the process of online admissions under various programmes run by the University Teaching Departments (UTDs) and USGS for the Session 2023-24.

COMPUTER SECTION, RESULTS BRANCH

The Computer Section, Results Branch has been established with aim to digitalize the data and preparation of results. The University is going to develop in-house software for Pre/Post Examination work with the association of NCCF, New Delhi an authorized agency for revamping/reforms in examination, timely declaration of results and issuing of DMCs to all the students of this University. The web-link named www.onlinecdlu.ac.in has been started/activated in this regard.

RESULTS BRANCH

Results Branch is an important Branch of Examinations Wing and working under the control & supervision of Controller of Examinations. The result processing (Pre & Post Examinations) has been switched over to digital platform. The admit card are also issued electronically. All results are also processed digitally. To upgrade examination work including result of the students, an MoU has been signed with NCCF for preparation of in-house customized softwares for pre and post examinations. Every year approx. 50,000 students of various affiliated Degree Colleges, Engg. Colleges, Management Institute, Education Colleges and University Teaching Departments are dealt with by the Results Branch. The prime objective of the Result, Branch is to provide timely declaration of results, DMCs and Degrees. The results and other details of individual students are made available online by providing individual login ID and password to each and every student. Further, the National Academic Depository (NAD) of UGC has also been implemented for the benefit of the students so that the students may access his/her Degrees/DMCs digitally anytime anywhere. The Learning Outcomes based Curriculum Framework (LOCF) for Post Graduate Programmes has also been implemented for the students of the University. Recently, UGC has introduced Academic Bank of Credits (ABC) Scheme. The University has also been implemented the same so that the students can use their earned credits of study in future.

SC/ST CELL

The SC/ST Cell has been established to provide facilities to the SC/ST students of the University as per the instructions of UGC/State Govt. from time to time. SC/ST Cell functions as Grievances Redressal Cell to redress the grievances of SC/ST Students and Employees of the university, and renders them necessary help in solving their academic as well as administrative problems. It also carries out any other work assigned from time to time so as to promote higher education among these communities, suffering from economic, social and education deprivations.

The main objective of the SC/ST Cell is to ensure proper implementation of various schemes of University Grants Commission/Govt. of India/State Govt. introduced from time to time in the interest of such students.

EDP CELL

The following project/tasks are being handled by the Electronic Data Processing (EDP) Cell.

- implementation of Digital University Framework (DUF) in the University w.e.f. session 2017-18. The web-link named cdlu.digitaluniversity.ac has been started/activated in this regard.
- The Android based application (mobile app) named -CDLU e-suvidha, is being handled by the EDP Cell and is available to download by the students free of cost at —Google Play Store.

COLLEGES BRANCH

The Colleges Branch headed by the Dean of Colleges constantly works in coordination with the affiliated Colleges/Institutes for promotion and raising the standards of Higher Education being imparted by the Affiliated Colleges. The Colleges Branch make efforts to improve the Physical & Academic Infrastructure and other facilities/amenities in all the affiliated colleges.
- 2. The Inspection Committees are constituted by the Vice-Chancellor to verify the infrastructure, other facilities and other relevant record available with the affiliated colleges
- 3. The Colleges Branch monitored all the Colleges to remove deficiencies, if any, pointed by the Inspection Committee at the time of Inspection.
- 4. The provisional affiliation/permanent affiliation are also granted to the Colleges affiliated with this University.

THE UGC CELL FOR COACHING SCHEMES

WELFARE SCHEMES FOR SC/DSC/BC STUDENTS

The University ensures proper implementation of various schemes of the UGC/Government of India/State Government concerning admission, scholarship etc. for the welfare of the students of reserved categories. The guidelines as revised from time to time by the Central and State Governments are displayed on the Notice Boards, prominent places and in the University prospectus for the benefit of the students belonging to SC/DSC/BC category. The guidelines are strictly adhered to. Apart from Post- Matric Scholarship for SC/DSC/BC students, the State Merit Scholarship for students with Physical Disabilities are also offered.

CAREER AND COUNSELING CELL

A Career and Counseling Cell has been established in the University to address the diverse socio- economic handicaps, linguistic differences and geographic backgrounds of the heterogeneous population of students coming to the University vis-à-vis equity of access and placement opportunities through availability of appropriate institutional support information. The Career and Counseling Cell also helps the students by providing appropriate guidance to establish linkages with the world of work and locate career opportunities. This cell is actively involved in carrying out vocational guidance and campus based interviews. The following are the major objectives of the cell:

- To gather information on job avenues and placements in different institutions and concerns related to the Programme(s) offered by this University.
- To analyze information in the local, regional and national contexts to explore its relevance and utility for the students in their placements and on job-training.
- To organize Seminars and Guidance Workshops for informing the students about the emerging Professional Trends and Events, job profiles, leadership roles, entrepreneurship, market needs and risks and implementation of national socio-economic policies and to impart training in soft skills.
- To promote discipline, healthy outlook and positive attitudes for strengthening National Integrationand removal of narrow provincial preferences and prejudice.

UNIVERSITY SCIENCE INSTRUMENTATION CENTRE

Recently, University Science Instrumentation Centre (USIC) has been established in CV Raman Bhawan (Science Block) of the University. It will work as Central Instrumentation Lab with necessary and sufficient sophisticated equipments of scientific importance within the reach of faculty members as well as research scholars for research activities. In addition, it will provide service for the maintenance of scientific instruments as far as possible.

INTERNAL QUALITY ASSURANCE CELL (IQAC)

The University has constituted the Internal Quality Assurance Cell (IQAC) to instil the momentum of quality consciousness and continuous assessment and improvement. The cell works to develop a quality system of conscious, consistent and catalytically programmed action for improving the academic and administrative performance of the HEIs and to promote measures for institutional functioning towards quality enhancement through internalization of quality culture and institutionalization of best practices. The IQAC achieved the above said

goals by offering itself the National Assessment and Accreditation Council (NAAC) for inspection. Grade from NAAC is considered Hall Mark of the quality of any HEI. The University has been Accredited with Grade —BII valid for a period of five years.

STUDENTS' WELFARE

This office is actively involved in issuing bus passes to the daily passenger students and organizes theevents like:

- 6. Organizes the Annual International Yoga Day on 21st June.
- 7. Arranges Students' Induction Programme/ Orientation Programme.
- 8. Organizes Annual Athletic Meet.
- 9. The facilities of E-Riksha for students etc.

DIRECTORATE OF YOUTH WELFARE

The Directorate of Youth Welfare, Chaudhary Devi Lal University undertakes the cultural activities to strengthen the awareness of Indian heritage, foster positive values of goal setting, patience & perseverance, competitiveness yet mutual cooperation & co-ordination in the students. The directorate celebrates all important days such as Independence Day, Republic Day, National Youth Day, Martyrdom Day and International Women's Day to commemorate the sacrifices of our warriors and to motivate the students for patriotism. Chaudhary Devi Lal University Won 5 prizes at National Level Youth Festival held at Bengaluru, Karnataka. CDLU team participated in International Youth Festival too & mark their presence by winning the medals. We are among the fastest growing entity & ensure the overall development of the student.

SPORTS COUNCIL

Sports activities of the University are being run under the Sports Council. UNIVERSITY HEALTH CENTRE

The university Health Centre located in the Shopping Complex on the 1st floor from room no. 101-104. It has sufficient place for OPD, dispensary and inward. It has facility of consultation, medicines & laboratory tests, treatment at free of cost. There is an Ambulance to carry the sick students to referral hospitals. The Health Centre provides its services during games, physical efficiency tests and functions organized by university. The students, the employees of the university and their dependents are availing the medical facilities being provided by the University Health Centre.

YOUTH RED CROSS

Youth are the pillars and future leaders of the country. Today's youth is tomorrow's India. The Youth Red Cross, the youngest wing of Indian Red Cross Society, Haryana State Branch is active at the University Level. A Youth Red Cross Unit is working in the University Campus for this purpose. A fifteen member YRC Committee of CDLU, Sirsa has been constituted under the chairmanship of the Vice-Chancellor to promote the YRC activities in all the colleges/institutions within the jurisdiction of the university. Meeting of Executive Committee at University Level and of students volunteers are called from time to time to decide about the YRC future plans.

RESEARCH & DEVELOPMENT CELL

University has a functioning office of Dean Research which acts as a pivot entity to streamline and coordinate research related activities. Of lately, the office of Dean Research has been restructured keeping in line with University Grants Commission circulars in this regard. Accordingly, a Research & Development Cell has been established in the University which comprises six different bodies. The Cell is guided by its apex body namely Research Advisory Council which lays down the goals of the Cell. Five other committees namely Finance and Infrastructure Committee, Research Programme and Policy Development Committee, Collaboration and Community Committee, Product Development and Commercialization Committee, and IPR, Legal and Ethical Matters Committees have also been constituted to achieve the goals set by the Advisory Council. Cell is headed by the Dean Research and coordinated by Coordinator, R&D Cell

RTI CELL

The RTI Cell deals with RTI applications and RTI appeals on behalf of the University under the provision of the RTI Act and provides information to the information seekers.

ANTI RAGGING COMMITTEE

Anti-Ragging Committee supported by Anti Ragging Squad and a Nodal Officer ensures that there are no incidences of Ragging, bullying and baiting of new students on the campus. Ragging is a criminaloffence and is strictly prohibited in the University. A student, if affected, can approach the Nodal Officer to redress his complaint. The Committee comprises Proctor, Dean Student's Welfare, Chief Wardens, Director Youth Welfare, Assistant Dean Students' Welfare and Hostel Wardens are also members of the Anti Ragging Committee/ Squad/Cell. The Anti Ragging Committee also has some outside members prominent along whom are SDM and DSP head quarter Sirsa besides some other important citizen of Sirsa.

ANTI EVE-TEASING COMMITTEE

EVE-teasing is a criminal offence. Making unwanted gestures towards girls or passing offensive comments are not only immoral acts but also subject to penal action under Indian Penal Code. Boys student are advised not to indulge in such acts. University has an Anti-Eve

teasing Committee headed by the Vice-Chancellor. The Committee comprises Dean Academic Affairs, Proctor, Chief Warden, Dean Students Welfare, Dean of Colleges, Controller of Examination, Lady Warden, SDM Sirsa, City Magistrate, Sirsa, DSP (HQ), Sirsa, SHO (City), Sirsa besides some student representatives and important citizens are also its members.

WOMEN COMPLAINTS COMMITTEE

Women Complaints Committee for women employees and girls against sexual harassment was constituted as per University Grants Commission (Prevention, prohibition and redressal of sexual harassment of women employees and students in higher educational institutions) Regulations, 2015.

UNIVERSITY COLLEGE

University College was started with 06 Teaching Departments in the Campus. Well-known, reputed and experienced academicians and professionals have been associated in preparing the academic curriculum of different programmes. It is important to mention here that special attention has been given to follow the guidelines of the UGC and other regulatory bodies in preparing the programme curriculum. The emphasis is to impart quality education by providing congenial and liberal atmosphere in the campus through the promotion of extracurricular activities. More emphasis are laid down on the learning outcomes and the development of cognitive and streaming students.

NATIONAL SERVICE SCHEME

- 1. No one who is already in employment (whole time or part time or in honorary capacity) shall be admitted to this Course in department of Education without taking leave from the employer for full academic session.
- 2. It will be the responsibility of the candidate to ensure eligibility for admission before applying for the course. If on verification at a later stage, it is found that a candidate does not fulfill the eligibility conditions, his/her candidature will be cancelled and the fee deposited by him/her shall be forfeited.
- 3. On-line registration-cum-Counselling fee shall be deposited by the candidate online through Credit / Debit Cards and Net Banking.
- 4. All the candidates must verify their personal information during online registration.
- 5. Candidates must take print-out of their online Application Form. This print-out has to be signed and submitted at the time of reporting for admission.
- 6. The outcome of counselling will be displayed on www.cdlu.ac.in; cdluadmissions.ac.in as per admission schedule. No individual allotment letter will be sent to the candidates applying Registration and password allotted to them and report to the allotted college.
- 7. Candidates will produce all the relevant certificates in original including registration-cumcounselling fee receipt for verification.
- 8. At the time of reporting, if documents are found to be correct on verification by the Department then provisional admission letter will be issued to the candidate by the department. The candidate shall check all the entries in this provisional admission letter and should sign it and preserve it for further reference.
- 9. If a candidate is admitted on the basis of the information submitted by him/ her, which is found to be incorrect or false at any stage then his/ her admission shall be cancelled and all fees and other dues paid by him/ her shall be forfeited. The University may take further action, as deemed fit, against the candidate in accordance with law.
- **10.** All the rules and regulations for submission of migration certificates by the candidates who have passed the qualifying examinations from other Universities will be applicable as per the rules of the University.

ONLINE ADMISSION PROCEDURE

The candidates who seeks admission in ITEP (B.A.B.Ed.& B.Sc.B.Ed.) Started by Department of Education Chaudhary Devi Lal University Sirsa may follow the following steps for counselling and admission process.

A. Online Registration

- Candidate should visit website www.cdlu.ac.in; cdluadmissions.ac.in
- Candidates should go through Handbook of Information for gathering information/instructions in detail about counselling schedules and procedures. Softcopy is available on the websites www.cdlu.ac.in; cdluadmissions.ac.in
- For Counselling in ITEP, The candidates will report in the department of education as per key dates mentioned in the admission schedule.
- For participation in online admission process, a candidate has to register by submitting personal data/requisite information correctly in the online application form. On submitting this data/ information user Id and password will be generated/ created for use in future logins by the candidate.
- For subsequent logins, candidates will be able to login directly with their user Id and password. Candidates should remember to logout at the end of their session so that the details filled by them cannot be tampered with or modified by unauthorized person.
- Candidates are advised to record/remember their password for future logins and not to disclose or share their password with anybody.
- It is solely the responsibility of the candidates to verify that their personal data including Category, Subcategory, Group (Science and Arts), Residential Status, gender etc. are consistent with documentary evidence.
- If the personal data submitted /entered by the candidates are found to be wrong at the time of certificate verification either during reporting or at a later stage, the allotment of seat/provisional admission is liable to be cancelled.
- Candidates should take a print out (hard copy) of the online application form containing the above personal data for future use.

B. Payment of Registration & Counselling Fee

- For depositing of registration and counselling non-refundable fee of Rs. 1000/- for General Candidate and Rs. 625/- for SC/BC/DAP and Girl candidates of Haryana State, visit website www.cdlu.ac.in and select mode of payment available on above website for the deposition of registration and counselling fee.
- Last date for payment of Registration-cum-counselling fee for Counselling in ITEP in department of education is as per key dates mentioned in the admission schedule (HBI).

Note-The candidate fails to registered as per the dates mentioned in admission schedule cannot be considered for admission in ITEP.

• Candidates must take a print out of their submitted application form . This print out has to be signed and submitted at the time of reporting for admission.

C: Online Seats Allotment

First Physical Counselling

Seats will be allotted as per the counselling Schedule and seat matrix mentioned in HBI. Candidates will have to personally report to the department of education Chaudhary Devi Lal University Sirsa for subsequent counselling as per schedule.

Second Counselling

Seats will be allotted against vacant seats available after the first round of allotment and reporting. Registered candidates who were not allotted seats in the first round of seat allotment will be considered for second round of counselling. The Candidates who, at any stage, cancel their provisional admission will not be considered for the subsequent round(s) of counselling. Also, if candidates fail to satisfy the minimum educational qualifications prescribed, their allotment of the seat shall automatically stand cancelled and such candidates will not be considered for the subsequent round(s) of counselling.

D Reporting at department of Education for admission in ITEP

The outcome of the different rounds of seat allotment will be displayed on the websites www.cdlu.ac.in; cdluadmissions.ac.in.(as per admission schedule). Individual allotment letters will not be sent to the candidates by the university. All the candidates who get an allotment should take print out of there application form and will report to the department of Education as per specified schedule for taking admission, failing which their seat allotment shall stand cancelled. Candidates will produce all the relevant certificates in original including registration and counselling fee receipt for verification along with provisional allotment letter, a signed print out of their online application form. At the time of reporting if documents are found correct on verification and the fee is paid (as mentioned in the Handbook of Information) by the candidate, then a provisional admission letter will be issued to the candidate by the department. The allotment of their seats is liable to be cancelled, if the personal data viz. Category, Sub-category, Group (Group-I Science, Group-II Arts) residential status (Bonafide Residents of Haryana or All India Category), percentage of marks in qualifying examination, gender etc. submitted by the candidates at the time of registration is found to be wrong at time of verification of the original certificates, But, if the candidate is found to be eligible after the correction in personal data, the candidate may be considered for subsequent rounds of counselling, if any, against the vacancies only. If a candidate is admitted on the basis of the information submitted by him/ her, which is found to be incorrect or false at any stage then his/her admission shall be cancelled and all fees and other dues paid by him/ her shall be forfeited. The University may take further action, as deemed fit, against the candidate in accordance with law. The allotment of the seats to candidates who do not report within the stipulated period to the department of Education will be cancelled.

List of documents to be brought at the time of reporting in the institute:

The candidates, at the time of reporting must bring the following Original Certificates/ Documents/ Testimonials along with two sets of duly attested photocopies with them. Any candidate, who fails to produce any of the required Certificate/Document /Testimonial at the time of reporting the institution, will forfeit his/her claim to admission.

(b)Gaps in study: Candidate who have gaps in their academic career after the qualifying exam., must furnish a gap certificate, in the form of affidavit on non-judicial stamp paper (v)Residents Certificate as per Annexure- XXI, if applicable: Candidates, who have passed their qualifying examination from a school located in the State of Haryana will be deemed to

be Haryana residents and will not be required to submit certificates of bonafide residents of Haryana.

- (v) Scheduled Caste Certificate as per Annexure- XII, if applicable.
- (vi) Backward Class Certificate as per Annexure- XIII, if applicable
- (vii) Certificate in respect of Persons with Disabilities Candidates if applicable.
- (viii) Certificate required to be furnished by the Children & Grand-children of Freedom Fighters as per Annexure- XVII, if applicable.
- (xi) Certificate from Ex-Servicemen of Indian Deference Services or Para-Military Forces-Annexure- XVIII.
- (xii) Provisional Allotment Letter
- (xiii) Original Receipt of Registration & Counselling Fee.
- (xiv) Print out of Online Application form along with their locked Choice.

Note:

- (i) All Original documents, 04 latest passport size photographs and 02 sets of attested photo-copies of all applicable documents/testimonials/certificates must be brought at the time of reporting.
- (ii) The original certificates shall be returned back after verification by the department.
- (iii) 2 sets of attested copies of certificates/documents/testimonials will be verified & signed by the Principal or his authorized representative & will be retained for registration purposes in the University.
- (iv) If the original certificates are not in Hindi/ English, duly certified Hindi/ English version/ translation of such certificates will be required.

INSTRUCTIONS FOR DEPARTMENT

- 1. The Department shall constitute an Admission Committee to be appointed by the Vice Chancellor from amongst the teachers of the Department.
- 2. Verification of the documents of the candidate will be done by the respective Admission Committee of Department at the time of reporting for admission, by comparing with the original certificates against which candidate has been allotted seat. Any entry or information filled/ made by the candidate, if found to be false, shall entail automatic cancellation of admission.
- 3. The admission committee shall ensure that the Candidate has deposited the fee as per his / her entitlement.
- 4. Department is required to update admission status online on www.cdlu.ac.in, cdluadmissions.ac.in strictly as per admission schedule so that the subsequent counselling may be conducted as per schedule mentioned in HBI
- 5. Information about only those candidates, whose admission status has seen reported online, will be forwarded to Registration Branch of University
- 6. All the rules and regulations for submission of Registration Return of students admitted in ITEP will be applicable as per the rules of the University.
- 7. Under no circumstances the original certificates of the candidate should be retained by the department, the candidate seeking admission will submit two sets of his/her documents/certificates duly self-attested by Candidate, at the time of reporting in the department. The Chairperson of the department will authenticate these documents/certificates after comparing these from the originals and the originals will be returned to the candidate

Eligibility Conditions

Eligibility Conditions for Admission to ITEP as per NCTE Norms are as under:

- (a) Candidates with at least 50% marks in 10+2/Intermediate/Senior Secondary School Examination in Science and Arts Stream, are eligible for admission to the programme.
- (b) The relaxation is applicable for SC/ST/PWD categories as per the rules of the Central Government/State Government.

Note:

- (i) There shall be no rounding off of percentage of marks of the qualifying examination from 0.5% and above to next higher number for determining the eligibility i.e. 49.5% and above will not be rounded off to 50%.
- (ii) 47.5% marks for SC/ST candidates of Haryana State only. As per letter dated :-16-07-2014
- (iii) 47.5% marks for Blind /Persons with Differently Abled and visually/Hearing Impaired candidate.

(iv) Compartmental candidates will not be allowed for admission in ITEP in any case.

PREPARATION OF MERIT LIST FOR ADMISSION

Merit for admission in ITEP shall be based on scores obtained in the NCET examination Conducted by NTA. However, if two or more candidates have obtained equal marks, following procedure will be used for the preparation of merit.

- (i) Candidate senior in age will be given first preference
- (ii) If tie still persists, then marks obtained in 12th will be considered
- (iii) If tie still persists, then marks in 10th will be considered to break the tie

DIVISION OF SEATS

50 of the total seats in each college shall be reserved for Group-I i.e. Science group candidates. Other 50 seats shall be reserved for Group-II i.e. Arts Group Candidates.

RESERVATION OF SEATS

1. Department of Education:

- (A) 15% of the total seats shall be open and will be filled on All India basis including Haryana.
- (B) Remaining 85% seats are reserved for bona fide residents of Haryana and will be filled up as detailed below:

The seat matrix has been prepared on the basis of the reservation policy notified by the Govt. of Haryana vide Notification No. 22/10/2013 – IGSIII dated 28/2/2013 and 22/12/2019-1GS.III dated 25.02.2019, and instructions received from the State Govt. from time to time on the following basis:

In the event of quota reserved for Physically Handicapped remain unfilled due to non-availability for suitable category of Handicapped Candidates, it may be offered to the Ex-Servicemen and their wards (1%) and the dependents of Freedom Fighters (1%).

Further, 3% reservation is also provided to Ex-serviceman/ Freedom Fighter and their dependents by providing reservation within reservation of 1% of General Category, 1% out of Scheduled Caste and 1% from Backward Classes category for admission to the various educational institutions of the Govt. and Govt. aided / Institutes located in Haryana. As far as Block allocation in Block-A and Block-B of Backward Classes category is concerned year wise rotational system will be adopted. For example, if Block-A of Backward Classes are given seats in academic year 2014, the next Block i.e. (B) Block of Category of Backward Classes will be given seats in the next academic year 2015 and so on. Further, a roster register for reservation of seats for ex- servicemen/freedom fighter shall be maintained and carry forward all fractions till one seat is accumulated through different fractions over the years. As and when the total comes to one seat will be provided. The Chairperson of the Department and Principal of the college concerned shall maintain the record for the purpose.

Definitions of Disabilities:

Definitions of categories of disabilities are given below:

- (I) (a) Blindness: "Blindness" refers to a condition where a person suffers from any of the following conditions namely:
 - i) Total absence of sight; or
 - ii) Visual acuity not exceeding 6/60 or 20/200 (snellen chart) in the better eye with correcting lenses; or
 - (i) Limitation of the field of vision subtending an angle of 20 degree or worse:

Low vision: 'Person with low vision' means a person with impairment of visual functioning

even after treatment or standard refractive correction but who uses or is potentially capable of using vision for the planning or execution of a task with appropriate assistive device.

- (II) Hearing Impairment: "Hearing Impairment" means loss of sixty decibels or more in the better ear in the conversational range of frequencies.
- (III) (a) Locomotor disability: "Locomotor disability" means disability of the bones, joints or muscles leading to substantial restriction of the movement of the limbs or any form of cerebral palsy.
 - (b) Cerebral Palsy: "Cerebral Palsy" means a group of non-progressive conditions of a person characterized by abnormal motor control posture resulting from brain insult or injuries occurring in the pre-natal, pre-natal or infant period of development.
 - (c) All the cases of orthopedically handicapped persons would be covered under the category of "locomotor disability or cerebral palsy".

Guidelines for Reservation:

- 1. The Reservation of seats is as per the Reservation Policy of the Haryana Govt. and is subject to any change/amendment by the State govt. from time to time.
- 2. In case seats of DSC remains vacant, the same will be filled up from the SC candidates and vice versa. Similarly, if the reserved seat(s) of BC Block 'A' remain vacant these will be filled up from BC Block 'B' and vice versa. Further, if the reserved seats of EWS category remains vacant, then these will be filled up from HOGC/AI open as the case may be.
- 3. If a candidate of Haryana General, SC and BC also applies for Differently Abled/ESM/DFF category, he/she will be considered first for Haryana General, SC and BC category.
- 4. If the quota reserved for Differently Abled Persons candidates remains vacant due to non-availability of candidates, these seats will be given to ESM and their wards, dependents of Freedom Fighters and wards of Military Personnel who died in operation 'Vijay' on the basis of their merit.
- 5. In case the number of applications is/falls less than the number of sanctioned seats in any Programme, the vacant seats under reserved categories except SC will be filled as follows:
 - I. The seats remaining vacant in any other Reserved Category shall be filled from Haryana Open category, if the candidate belonging to the respective category is not available at the time of physical presence.
 - II. Further, in case, the seats remain vacant in Haryana Open category, the same will also be thrown open to All India Open category.
 - III. In case the number of applications received in any category is less than the number of sanctioned seats, all the vacant seats will be thrown open to as per the above two clauses.
 - IV. No SC/DSC seat will be converted into General category.
 - V. Roster System will not be maintained in case of admissions as per Haryana Govt. instructions.
 - VI. Candidates claiming reservation under Scheduled Caste, Backward Class (Block 'A' & 'B') and EWS (Govt. notification and certificate available at www.cdlu.ac.in) categories will submit the certificate as per <u>Annexure-XII</u>, XIII and affidavit as per <u>Annexure-XIV</u> regarding income proof to decide creamy layer category, <u>Annexure-IX</u>, respectively.
- 6. Certificate from ward of Deceased/Disabled/Discharged Military/Para-Military personnel/Ex Servicemen or Ex-Personnel of Para-Military Forces Annexure- XV must be enclosed with the admission form for taking the benefit of reservation.

The seats reserved for ESM category shall be offered in order of following priorities:

- a) Wards of Ex-servicemen died in action while in active service.
- b) Ex-serviceman himself.

- c) Wards of Ex-servicemen.
- d) Wards of Paramilitary Forces.
- 7. Only the candidates having permanent disability of not less than 40% (being otherwise fit for admission to the Programme(s)) will be considered for admission as Differently Abled. Disability certificate must be issued by the Chief Medical Officer of the concerned District. The Admission Committee can recommend for verification in case of any doubt to the concerned Chief Medical Officer. Differently abled candidates belonging to Haryana are required to submit the certificate as per **Annexure-XVI**.
- 8. Children and Grand-Children of Freedom Fighters of Haryana are required to submit a certificate from the concerned Deputy Commissioner of the concerned District as per **Annexure-XVII.**
- 9. ESM and their wards of Haryana are required to submit the certificate as per Annexure- XVIII.
- 10. For horizontal reservation, ESM/DFF candidates of General, SC and BC category will also have to furnish ESM/DFF certificate as mentioned above.
- 11. In pursuance of the decision of Hon'ble Punjab & Haryana High Court, Chandigarh dated 11.01.2013 in the LPA 98/2013 (O&M) CWP No. 20359 of 2012, Sh. Ishwar Singh Vs KUK & Others, preference shall be given to ESM first before giving admission to wards against ESM reserved seats.
- 12. Eligible candidates whether from Haryana or from reserved categories will compete for seats allocated under All India Category.
- 13. A candidate, who applies for reserved category will be considered first in general category. In case, he/she does not get a seat of his/her choice in general category, then he/she will be considered for reserved category as applicable. The category of allotted seat may be higher than the actual category of the candidate.
- 14. If the number of seats in any particular category is not a round figure, 0.5 or above will be taken as one and less than 0.5 shall be ignored, except that in Physically Handicapped, Children & Grandchildren of Freedom Fighters and Ex-Servicemen and their Wards Categories, at least on candidate will be admitted from all the three categories in total, even if the share is less than 0.5 seats provided the number of sanctioned intake in the particular Programme(s) is 30 or above.
- 15. Candidates who have passed their qualifying examination from a university in the State of Haryana will be deemed to be Haryana residents and will not be required to submit certificates of bona fide residents of Haryana.
- 16. In case of tie for admission against sports seats, the applicant who has won position in higher tournament will be admitted.
- 17. A person belonging to the General Category married to a person belonging to the Scheduled Caste or Backward Classes, shall not be entitled to the benefit of reservation vide letter no. 22/76/2012-GSIII dated 22.03.2012 from Chief Secretary to Govt., Haryana.
- 18. The State Govt. of Haryana has decided to provide following concessions to the students belonging to Jammu & Kashmir for their admissions in the Colleges and Universities of Haryana.
- (i) Relaxation in cut-off percentage upto 10% subject to minimum eligibility requirement.
- (ii) Increase in intake capacity upto 5% course-wise.
- 19. The Govt. Notification No. 22/12/2019-1GS.III dated 25.02.2019 for Economically Weaker Section (EWS) is attached. The reservation in admission to the EWS candidates shall be given as per the Guidelines and Instructions supplied by the State Government i.e. 10% is to be given in both State Quota seats under State Policy and All India Quota seats under Central Government Policy separately (Annexure- XIX).
- 20. The State Reservation Policy is being followed.

21. The reservation policy of State of Haryana applied

- (2) Candidates have to apply for Admissions 2023 online ONLY by accessing the website. Application forms other than online mode will not be accepted in any case.
- (3) Candidates are advised to upload all the relevant documents and testimonials along with their application form for ascertaining their Date of Birth, Eligibility, Category as well as for calculating the Merit for Admission Purpose. Before starting to fill up the online application, keep ready with you the following details, and images of documents (size of image of any document should not exceed 50 kb):
 - (a) A Valid Email ID (the email should be valid for at least 1 year), a valid mobile number as all information via SMS will be sent to this number.
 - (b) Image of scanned photograph in jpg / jpeg format.

 - (3) **Gaps in study:** Candidate who have gaps in their academic career after the qualifying exam., must furnish a gap certificate, in the form of affidavit on non-judicial stamp paper or certificate from the employer (if in the service) and should also furnish separately the character certificate of gap period duly attested by Notary Public.

Note:

- (i) The candidates must ensure that they have obtained the relevant certificate(s) from the appropriate competent authority approved and notified by Govt. of Haryana.
- (ii) It is the sole responsibility of the candidate to upload all necessary documents/ certificates/ testimonials/fees with the application form. Discrepancy, if any, shall not be communicated to the candidates by the department/institute.
- (iii) Not uploading of required documents will be considered as incomplete application form. The same will be identified and rejected for admission by the Admission Committee of the concerned institute/ college.
- (iv) Upload the correct Photograph and Signature as the facility for correction in images will not be given.
- (4) Visit the official website and follow the following procedure:

- (a) Click on 'New registration' tab.
- (b) Fill basic details like email, mobile number, name, password etc.

Instructions regarding Bonafide Residents of Haryana issued vide letter No. 62/17 / 95-6 GSI dated 3rd October, 1996, No. 62/32/2000-6 GSI dated 23rd May, 2003, No. 62/27/2003-6 GSI dated 29th July, 2003 and No.62/62/2011- GSI dated 17th January, 2012 by the Chief Secretary to Government, Harvana.

Subject: Guidelines regarding Bonafide residents of Haryana.

- I am directed to invite your attention to Haryana Govt. letters noted in the margin on the subject noted above vide which the instructions were issued regarding simplification no procedure for obtaining the certificate of Domicile for the purpose of admission to educational institution (including technical / medical institution). The matter has been reconsidered in the light of judgment delivered by the Hon'ble Supreme Court of India in the case of Dr. Pradeep Jain vs. Union of India and others reported as AIR 1984-SC-1421, wherein it has been held that instead of the word 'Domicile' the word 'Resident' be used in the instructions issued by the State Government and it has been decided to revise the Government instructions. Henceforth, the following categories of persons would be eligible for the grant of Resident Certificate: -
- (1) Candidates, who have passed the examination qualifying therefore selection in an institution from a school/college in Haryana.
- (II) Children/Wards (if parents are not living)/ Dependents: -
 - (i) Of the regular employees of Haryana State posted in or outside Haryana State or working on deputation;
 - (ii) Of the regular employees of the statutory bodies/corporations established by or under an act of the State of Haryana who are posted in Chandigarh or in Haryana or outside Haryana.
 - (iii) Of the regular employees of the Government of India posted in Chandigarh or in Haryana in connection with the affairs of the Haryana Government;
- (III) Children/wards (if parents not living) / dependents of persons who after retirement have permanently settled in Haryana and draw their pensions from the treasuries situated in the State of Haryana.
- (IV) Children/wards (if parents are not living)/ dependents of pensioners of Haryana Government irrespective of the fact that the original home of the retiree is in a state other than Haryana or he has settled after retirement in or outside Haryana,
- (V) Children/Wards (if parents are not living)/ dependents of persons, who have permanent home in Haryana and include persons who have been residing in Haryana for a period of not less than 15 years or who have permanent home in Haryana but on account of their occupation they are living outside Haryana;
- (VI) The wives of such persons who are bonafide residents of Haryana irrespective of the fact that they had belonged to any other State before marriage;
- (VII) Persons who were born in Haryana and produce a certificate to that effect; provided that the parents/guardians (if parents are not living) of persons belonging to anyone of the above mentioned categories are:

- (a) Citizen of India:
- (b) Produce an affidavit to the effect that they or their children/wards (if parents are not living) / dependents have not obtained the benefit of Resident in any other State.
- (VIII) Children & Wards of the accredited journalists residing at Chandigarh and recognized by Govt. of Haryana.
- All candidates claiming to be bonafide residents of Haryana should produce a Haryana Resident Certificate signed by the District Magistrate/General Assistant to Deputy Commissioner or Sub- Divisional Officer (Civil) of the District/ Sub-Divisions /Tehsildars of Revenue to which the candidates belong. Resident Certificates in respect of elsewhere or in respect of the Children/Wards/Dependents of Haryana Govt. employees who are posted at Chandigarh, Delhi or elsewhere or in respect of Children/Wards/Dependents of pensioners of Haryana Govt. or in respect of the Children/Wards/Department of the employees of the Government of India posted at Chandigarh or in Haryana in connection with the affairs of Haryana Government, or in respect of Children/Wards/Dependents of the employees and retirees of the Statutory Bodies/Corporations of Haryana established by or under an Act of the State of Haryana or a Central Act and located at Chandigarh, Haryana or outside Haryana, should be by the irrespective Heads of Departments.
- 3 Candidates seeking admission in educational institutions (including medical and technical institutions) located in Haryana may not be required to produce Resident Certificate, if they have passed the examination from a school/college situated in Haryana. For this purpose, a certificate of the Principal/Headmaster from concerned institution where the children/wards studied last should be considered sufficient. The Principal/Headmaster of the institution shall be competent to issue such certificate, which should be sufficient.
- If a candidate is admitted on the basis of claim that he belongs to the State of Haryana but at any subsequent time is discovered that his claim was false, the student shall be removed from the institution, all fees and other dues paid upto the date of such removal shall be confiscated. The Principal/Headmaster may take such other action against the student and his/her parents/guardians as he may deem proper in the circumstances of any particular case.
- The children/wards/dependents of the employees of Punjab & Haryana High Court, who are discharging their duties in connection with the affairs of the State of Haryana and have not availed facility from their parent State, the State of Punjab and U.T. Administration Chandigarh, would also be eligible for grant of Resident Certificate of the State of Haryana only for the purpose of admission in academic/technical/medical institutions of the State of Haryana. However, in that case the employees of the Punjab & Haryana High Court shall be entitled to draw this benefit at one place/State only. Head of the Department of the Punjab & Haryana High Court would be competent to issue such a certificate.

The above mentioned Civil Appeal No. 2718-2020 (Arising out of SEP to No. 21129 of 2019) titled as Vryan Raj Vs. Chandigarh Administration and others florinte Supreme Court of India in its order dated July 08, 2020 observed that Scheduled Castes Scheduled Tribes candidates are required to obtained 35% passing marks to pass in the aptitude test as against the requirement of 40% for general candidates. The relaxed criteria of 35% pass marks in aptitude test shall apply to the candidates with disabilities also for admission.

The Hon'ble Supreme Court Directed all States/UTs to take up the matter with Department of Education, Culture, General Administration and other concerned department on the following aspects:-

- Adopt a uniform qualifying criteria for Persons with Benchmark Disabilities included the Rights of Persons with Disabilities Act. 2016 Candidates of Scheduled Castes and Scheduled Tribes categories for admission to various higher educational courses
- b. Issue appropriate advisory to all Universities to develop courses suitable for Persons with Intellectual developmental mental disabilities for their educational empowerment.
- Consider increasing such number of seats in the discipline of painting and applied art.

At the outset of discussion meeting, Sh. Devender Singh, ACSSDIT apprised that Haryana Board of School Education (HBSE), Bhiwani has recently provided equivalency to ITI courses (entry qualification 8th and 10th) with 10th or 10+2 for the purpose of vertical mobility into higher education as well as for employment opportunities. He also told that around 2321 ITI pass outs had appeared in the language exam taken by HBSE in July, 2019 & 63% have been got the equivalency certificate from HBSE and 92% trainees have opted the Hindi language. According to the granted HBSE equivalency to ITI pass outs, two separate issues are to be addressed as the following:

- (1) HBSE has provided an open equivalency to ITI pass outs which has opened the pathways for ITI pass-outs not only for Higher education but also for employment opportunities. As we aware that maximum of Group D and many of Group C posts in Haryana are being filled with the essential qualification as 10th and 10+2, a common rule/legislation is to be passed which is in process for all Departments/Boards/Corporations for considering eligible to equivalent ITI Pass holders for all such posts which have essential qualification as 10th and 12th.
- There is a need in the amendment in the entry qualification in the Bachelor (ii) courses as 10+2 or its equivalent so as to open the pathway for ITI

In respect of the needed amendment in the entry qualification in the Bachelor courses as 10+2 or its equivalent so as to open the pathway for ITI equivalency holders in B.A., B. Com., B.Tech. etc. The following discussion and decision were held during the meeting: Action I:

Voc. Courses. The process of issuing direction/ notification to colleges be completed by 31.10.19

Action II:

For availing admission to ITI pass outs in B. Tech./B.E. 1st year after clearing the common Engineering test.

Matter deliberated at a length and representative of AICTE Lt. Col. K. Bansal, Director, AICTE did not agree with the SDIT request and he clarified that only candidate with 10+2 with PCM can take admission in Engineering streams i.e. B. Tech./ B.E. Therefore, worthy CS has directed to re-examine the issue and

In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, in exercise of the powers conferred by clause (g) of sub-section (1) of section 26 of the University Grants Commission Act, 1956, the UGC notified "Regulations on Curbing the Menace of Regging in Higher Educational Institutions, 2009". The Regulations are available on the UGC website i.e. www.ugc.ac.in & www.antiragging.in.

It is once again brought to your kind notice that ragging is a criminal offence and UGC has framed regulations on curbing the menace of ragging in higher educational institutions in order to prohibit, prevent and eliminate the securge of ragging. These regulations are mandatory and all institutions are required to take necessary steps for its implementation in toto including the monitoring mechanism. Any violation of these regulations will be viewed seriously. If any institution fails to take adequate steps to prevent ragging or does not act in accordance with these Regulations or fails to punish perpetrators of incidents of ragging suitably, it will attract punitive action against itself by the UGC.

You are requested to step up anti-ragging mechanism by way of adequate publicity through various mediums: constitution of Anti-Ragging committee and Anti-Ragging squad, setting up of Anti-Ragging Cell, installing CCTV cameras at vital points, Anti-Ragging workshops and seminar, updating all websites with nodal officers' complete details, alarm bells etc. Regular interaction and counseling with the students, identification of trouble-triggers and mention of Anti-Ragging warning in the institution's E-prospectus and E-information booklets/brochures must be ensured. Surprise inspection of hostels, students' accommodation, canteens, rest cum recreational rooms, toilets, bus-stands must be carried out & Anti-Ragging posters must be displayed at all prominent places like Admission Centre, Departments, Library, Canteen, Hostel, Common facilities etc. These posters are available on UGC website www.ugc.ac.in. The size of posters should be 8x6 feet. Any other measure which would augur well in preventing/quelling ragging and any uncalled for behaviour/incident must be undertaken.

Students in distress due to ragging related incidents can call the National Anti-Ragging Helpline 1800-180-5522 (24x7 Toll Free) or e-mail the Anti-Ragging Helpline at helpline@antiragging in. For any other information regarding ragging you may please visit the UGC website i.e. www.ugc.ac.in@www.ugc.ac.in@www.antiragging.in and contact UGC monitoring agency i.e. Centre for Youth (C4Y) on Mobile No. 09818044577 (only in case of emergency).

UGC also drives an Anti-Ragging Media Campaign through different modes and has undertaken the following activities to promote the campaign which are available on UGC website i.e. www.ugc.ac.in

- UOC developed 05 TVCs of 30 seconds each with different perspective i.e. Parents, Victim and Offenders.
- b. UGC designed and distributed 04 types of posters amongst Universities / Regulatory Authorities / Councils / IITs / NITs / other educational institutions for their prominent display.
- c. UGC consecutively organized 02 Anti-Ragging Competitions for students/faculty/general public for the wider awareness of the menace of ragging.

In compliance of the 2nd Amendment in UGC Regulations, you are requested to make it compulsory for each student and every parent to submit an online undertaking every academic year www.antiragging.in

You are also requested to implement the revised procedure for students to file online Anti-Ragging amdavit. The student will receive an e-mail with his/her registration number. The student will forward that e-mail to the Nodal officer in his/her university/college e-mail. [Please note that the student will not receive pdf affidavits and he/she is not required to print a sign it as it used to be in the earlier case).

Respected Madam/Sir,

As you are aware that the University Grants Commission has issued the UGC guidelines on examination and academic calendar in view of the Covid-19 pandemic on 16th July, 2021, wherein UGC has stipulated the provision of refund of fees on account of all cancellations of admissions/ migrations of students during the academic session 2021-2022 Also, UGC on 12th July, 2022 has requested the higher educational institutions to fix the last date of their under graduate admission process after declaration of result of class XII by CBSE so as to provide sufficient time to such students for admission in under graduate courses. Also, it may be noted that several entrance examinations including CUET, JEE Main, JEF, Advance etc. have been delayed, due to which admissions may continue up to October, 2022.

In view above, and in order to avoid financial hardships being faced by parents, it has been decided by UGC that full refund of fees should be made by the higher educational institutions on account of all cancellations of admissions/ migrations of students up to October 31, 2022 for the academic session 2022- 2023 as a special case. It is made clear that the entire fee, including all charges, should be retunded (i.e., there should be zero cancellation charges) on account of cancellations/ migrations up to October 31, 2022 Thereafter, on cancellation/ withdrawal of admissions up to December 31, 2022, the entire fee collected from a student should be refunded in full after deducting not more than Rs.1000/- as processing fec.

All the Higher Educational Institutions are requested to ensure the compliance of the UGC directions in respect of refund of fee in view of COVID-19 Pandemic related factors

State Government has been empowered under Section 8 of the Act to prescribe Parivar Pehchan Number (PPN) as a requirement for the purpose of determining above mentioned eligibility or provision. The verified information linked with PPN available in Family Information Data Repository (FIDR) has now made it feasible to issue Income Certificates across the counter through SARAL portal Keeping in view the above. Government has decided to issue instructions regarding issuance of Income Certificates, in suppression of previous instructions, if any Portal for issuance of Income Certificate.-Income Certificate shall be issued to eligible residents of Haryana on provision of PPN through the SARAL portal (https://saralharyana.gov.in/) facsimile signed by ADC-cum-DCRIO (Additional Deputy Commissioner cum District Citizen Resources Information Officer) These certificates will be issued on the basis of verified data on income contained in FIDR Person who is entitled to obtain Income Certificate.-(ii) A person who is a resident of State of Haryana shall be entitled to obtain Income Certificate on provision of PPN and having income verified in FIDR. - (ii) An Income Certificate may become invalid at any time during the financial year. If after due process, it has been concluded that the income was incorrectly mentioned on the certificate or wrongly verified in the FIDR, due to any reason whatsoever.

(vii) Grievance Redressal and Correction Process.—

If an applicant is not in agreement with his income contained in the FIDR, then he she may lodge his her grievance for re-verification on the Grievance Module of the PPN portal (https://meraparivar.haryana.gov.in/ReportGrievance). The grievances will be dealt with as per the mechanism separately notified by Haryana Parivar Pehchan Authority under the provisions of the Haryana Parivar Pehchan Act, 2021.

(viii) General Terms and Conditions.-

- (a) The Income Certificate is usable without any restriction wherever it is accepted (i.e., subject to the criteria laid down by the entity accepting the certificate) and hence no usage/applicability restrictions shall be mentioned on the certificate.
- (b) From the effective date of this order, only the Income Certificates issued through SARAL portal in the format prescribed by the Citizen Resources Information Department, based on PPN and corresponding verified data contained in the FIDR shall be valid Income Certificates.
- (c) An Income Certificate obtained by means of any fraud, misrepresentation or concealment of facts or by any other illegal means shall be declared as invalid and the benefit availed by the candidate/applicant shall be withdrawn and legal action including criminal proceedings will be initiated against the applicant for misrepresenting the facts and playing fraud, as well as against the officials/authorized persons for incorrect/ wrong verification by collusion or otherwise. In such an event, the income shall

be marked as NOT VERIFIED in the FIDE

- (d) Mere issuance of an Income Certificate does not entitle a person holding such certificate to any benefit that may be admissible under various Government schemes implemented from time to time Hence, it is important that the authority concerned examines the applicant's entitlement to any specific henefit in accordance with the instructions on the subject at any given point of time. Other eligibility criteria for a particular scheme shall be addressed separately by the authority extending such benefit
- (c) All Haryana Government organisations (including Departments, I ducational Institutions, Boards, Corporations and Societies) are required to accept the Income Certificate in its standard format prescribed by the Citizen Resources Information Department from time to time
- (f) Any Government organisation accepting physical copy of the meome Certificate for the purpose of any scheme, benefit etc. may check the realtime status of the verified income of the person to whom the certificate pertains, on the PPP portal

No Government Department of Haryana shall obligate any resident of the State to submit income related proof documents if he/she provides PPN and his/her income is marked as verified in Lamily Information Data Repository (FIDR).

Reservation for Economically Weaker Sections in Direct recruitment in Civil posts and services as well as in admissions in Government/Government Aided Educational Institutions in the State of Haryana.

I am directed to inform that Government of India has notified "THE CONSTITUTION (ONE HUNDRED AND THIRD AMENDMENT) ACT, 2019" on 12th January, 2019 amending Article 15 & 16, which now read as

Amendment of article 15

In Article 15 of the Constitution, after clause (5), the following clause shall be inserted, namely:—

- '(6) Nothing in this article or sub-clause (g) of clause (1) of article 19 or clause (2) of article 29 shall prevent the State from making,—
- (a) any special provision for the advancement of any economically weaker sections of citizens other than the classes mentioned in clauses (4) and (5); and
- (b) any special provision for the advancement of any economically weaker sections of citizens other than the classes mentioned in clauses (4) and (5) in so far as such special provisions relate to their admission to educational institutions including private educational institutions, whether aided or unaided by the State, other than the minority educational institutions referred to in clause (1) of article 30, which in the case of reservation would be in addition to the existing reservations and subject to a maximum of ten per cent. of the total seats in each category.

Explanation— For the purposes of this article and article 16, "economically weaker sections" shall be such as may be notified by the State from time to time on the basis of family income and other indicators of economic disadvantage."

Amendment of article 16

In Article 16 of the Constitution, after clause (5), the following clause shall be inserted, namely:—

"(6) Nothing in this article shall prevent the State from making any provision for the reservation of appointments or posts in favour of any economically weaker sections of citizens other than the classes mentioned in clause (4), in addition to the existing reservation and subject to a maximum of ten per cent, of the posts in each category".

In the wake of above enabling provisions, State Government has considered the matter and decided to provide benefits of reservation on a preferential basis in Civil Posts in all its Departments/ Boards/ Corporations/Local Bodies and in Admissions to Government/Government Aided Educational institutions to those Economically Weaker Sections (EWSs) who are not covered under the existing scheme of reservation for the Scheduled Castes Backward Classes (Block-A) and Backward Classes (Block-B)

2. QUANTUM OF RESERVATION:

The persons belonging to EWSs who are not covered under the existing scheme of reservation for Scheduled Castes, Backward Classes (Block-A) and Backward Classes (Block-B) shall get 10% reservation in direct recruitment to Group A.B.C and D posts in the Departments/ Boards/Corporations/Local Bodies of Government of Haryana and also in admission to Government/Government Aided Educational Institutions in the State of Haryana.

3. EFFECTING RESERVATION - ROSTER POINT;

- 3.1 Direct recruitment in case of Group- A & B

 Roster point No 11-20-30-40-51-60-70-80-90 and 99
- 3.2 Direct recruitment in case of Group- C & D

 Roster point No. 4-14-24-34-43-53-66-76-83 and 94
- 3.3 Where in any recruitment year any vacancy earmarked for EWS cannot be filled up due to non availability of a suitable candidate belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog and will be filled from unreserved category.
- 3.4 Persons belonging to EWS selected against the quota for persons with benchmark disabilities/ex-servicemen shall be placed against the rester points earmarked for EWS.

4. CRITERIA OF INCOME & ASSETS

- Persons who are not covered under the exiting scheme of reservation for Scheduled Caste Backward Classes (Block-A) and Backward Classes (Block-B) and whose family has gross annual income below Rs 6.00 takh (Rupees six takh only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources Le. salary, agriculture, business, profession etc. for the financial year prior to the year of application.
- 4.2 Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:-
 - 6 acres of agricultural land and above;
 - ii. Residential flat of 1000 sq ft, and above;
 - Residential plot of 100 sq. yards and above in notified municipalities;
 - Residential plot of 200 sq. yards and above in areas other than the notified municipalities.
 - Total immovable assets owned are valued at Rs. One Crore or more.
- 4.3 The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.
- 4.4 The term "Family" for this purpose will include the person who applies for benefit of reservation, his/her parents, spouse as well as children and siblings below the age of 18 years.

5. INCOME AND ASSET CERTIFICATE ISSUING AUTHORITY AND VERIFICATION OF CERTIFICATE:

- 5.1 The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate Issued by a Competent Authority The Competent Authority for EWS Income and Asset Certificate shall be Tehsildar of the area where the applicant normally resides.
- 5.2 The prescribed format for EVVS Income and Asset Certificate shall be as provided at Annexure-I.
- 5.3 The Officer who issues the certificate would do the same after carefully verifying all relevant documents following due process as prescribed by the State
- 5.4 The crucial date for submitting Income and Asset Certificate by the candidate may be treated as the closing date for receipt of application for the post, except in cases where crucial date is fixed otherwise.

5.5 The appointing authorities should in the offer of appointment to the clause .

The appointment is provisional and is subject to the Income and asset contribute being ventiod through the proper channels and if the ventication reveals that the claim to belong to EWS is fakefulse the services will be reministed fortherm without assigning any further reasons and without projudice to such further nation as may be taken under the provisions of the Indian Penal Code for production of takefulse certificate."

The appeinting authority should verify the veracity of the Income and asset certificate submitted by the candidate through the certificate issuing authority.

5.6 Instructions referred to above should be strictly followed so that it may not be possible for an unscrupulous person to secure employment on the basis of a faise claim and if any person gets an appointment on the basis of such false claim, her/his services shall be terminated and penal action shall also be invoked.

B. ADJUSTMENT AGAINST UNRESERVED VACANCIES:

A person belonging to EWS cannot be denied the right to compete for appointment against an unreserved vacancy. Persons belonging to EWS who are selected on the basis of ment and not on account of reservation are not to be counted towards the quota meant for reservation.

 The above scheme of reservation will be effective in respect of all direct recrument vacancies to be notified on or after 01.02.2019.

- (3) A female student of M.Phil. & Ph.D. on valid adoption of a child below the age of one year may be granted child adoption leave for a maximum period of six months or up to the date of attaining the age of one year by the adopted child, whichever is earlier.

OTHER FACILITIES

Examination Form: If filling of Examination form is delayed due to Pregnancy/abortion//adoption of child, two weeks extension will be provided to the student by submitting medical certificate/ authentic document.

Assignments: If submission of Assignments/ Mid-term- Examination/Progress report/Progress seminar is delayed due to Pregnancy/abortion//adoption of child, two weeks extension will be provided to the student by submitting medical certificate/ authentic document.

Examinations: Immediately after availing her maternity leave the student will be allowed to give examination on her written request to competent authority by submitting Medical fitness certificate/relevant authentic document. It is compulsory to submit all her academic assignments /mid-term examination/dissertation work/Project reports before theory examination.

Practical: Immediately after availing maternity related leaves student will be allowed to give her practical examination / viva -voice on her written request along with medical certificate of fitness/relevant authentic document.

Subject: Bona fide Residents of Haryana – Guidelines regarding

Sir/Madam,

I am directed to invite your attention to Haryana Govt. letter on the subject noted above vide which the instruction were issued regarding simplification of procedure for obtaining the certificate of Domicile for the purpose of admission to educational institutions (including technical/medical institutions). The matter has been reconsidered in the light of judgment delivered by the Hon'ble Supreme Court of India in the case of Dr. Pradeep Jain vs. Union of India and other reported as AIR 1984.SC.1421, where in it has been held that instead of the word 'Domicile' the word 'Resident' be used in the instructions. Henceforth the following categories of persons would be eligible for the grant of Resident certificate:

- a. Candidates who have passes the examinations qualifying them for selection in an institution from a school/college in Haryana.
- b. Children/wards (if parents are not living) Dependent:
 - i. of the regular employees of Haryana State Posted in/outside Haryana State or working on deputation.
 - ii. of the regular employees of the statutory bodies/corporations established by or under an Act of the State of Haryana who are posted in Chandigarh or in/outside Haryana;
 - **iii**. of the regular employees of the Government of India posted in Chandigarh or in Haryana in connection with the affairs of the Haryana Government.
- c. Children/wards (if parents not living) dependents of persons who after retirement have permanently settled in Haryana and draw their pension from the treasuries situated in the State of Haryana.
- d. Children/Wards (if parents not living)/ dependents of pensioners of Haryana Government irrespective of the fact that the original home of the retiree is in a State other than Haryana or he has settled after retirement in or out side Haryana.
- e. Children/Wards (if parents not living)/dependents of persons who have permanently home in the Haryana and include persons who have been residing in Haryana for a period of less than 15 years or who have permanent home in Haryana but on account of their occupation they are living out side Haryana
- f. The wives of such persons who are bona fide resident of Haryana irrespective of the fact that they had belonged to any other State before marriage.
- g. Persons who were born in Haryana and produce a certificate to that effect; provided that the parents/Guardians (if parents are not living) of persons belonging to any one of the above mentioned categories are:
 - i. Citizen of India;
 - **ii**. Produce an affidavit to the effect they or their children/ wards (if parents are not living)/dependents have not obtained the benefit of Resident in any other State.
- 2. All candidates claiming to be Bona fide residents of Haryana should produce a Haryana Resident

Certificate singed by the District Magistrate / General Assistant of Deputy Commissioner of Sub-Divisional Officer (Civil) of the District/Sub-divisional to which the candidates belong. Residents Certificate in respect of elsewhere or in respect of the Children/Wards/dependents of Haryana Govt. Employee who are posted at Chandigarh, Delhi or elsewhere in respect Haryana in connection with affairs of Haryana Govt. or in respect of Children/Wards/dependents of the employees and retirees of the Statutory bodies/ Corporations of Haryana established by or under an Act of the State of Haryana or Central Act and located at Chandigarh, Haryana and outside Haryana, should be issued by their respective heads of Departments.

- 3. Candidates seeking admission in the Educational Institutions (including medical and technical institutions) located in Haryana may not be required to produce resident certificate, if they have passed the Examination from a School/College situated in Haryana. For this purpose a certificate of the Principal/Headmaster of the Institution shell, be competent to issue such certificate, which should be sufficient.
- 4. If a candidate is admitted on the basis of claim that he belongs to the State of Haryana but at any subsequent time is discovered that his claim is false, the student shall be removed from the institution, all fees and other dues paid up to the date of such removal shall be confiscated. The Principal may take such other action against the students and his /her parents/ Guardians as he may deem proper in the circumstances of any particular case.

GUIDELINES FOR SC/DSC SCHOLARSHIP GOVT. OF INDIA POST MATRIC SCHOLARSHIP SCHEME FOR SCHEDULED CASTES STUDENTS

I. Conditions of Eligibility

- (i) The scholarships are open to nationals of India.
- (ii) Theses scholarships will be given for the study of recognized post-matriculation for postsecondary programmes pursued in recognized institution with the following exception. "Scholarships are not awarded for training programmes like aircraft maintenance Engineer's Programmes and Private pilot license Programmes. Programmes at Training ship dufferin (Now Rajendera) Programmes of training at the Military College, Dehradun, programmes at pre-examination Training Centers of all India State levels."
- (iii) Only those candidates who belong to Scheduled Caste so specified in relation to the State/Union Territory to which the applicant actually belongs i.e. permanently settled and who have passed the matriculation or Higher Secondary Education, will be eligible.
- (iv) Candidates who after passing one stage of education are studying in the same stage of education in different subject e.g. MSc after BA or B.Com. and after BA or MA in other subject will not be eligible.
- (v) Students who after having completed their educational career in one professional line. e.g. LLB. after B.T. /B.Ed. will not be eligible from the academic year 1980-81, studies in two professional programmes are allowed.
- (vi) Students studying in Class XI of the Higher Secondary School programmes of the XII class of the multipurpose high school will not be eligible for it being a continuous school programme. However, in cases where tenth Class examination of such programmes is treated as equivalent to Matriculation and students who after passing tenth class join other programmes, such students will be treated as post-matric students and will be eligible for the award of scholarships.
- (vii) Students pursuing Post graduate programmes in medicine will be eligible if they are not allowed to practice during the period of their programme.
- (viii) Students who after failing or passing the under graduate/Post- graduate examinations in Arts/ Science/Commerce join any recognized professional or Technical certificate/ diploma/ degree programmes will be awarded scholarships if otherwise eligible. No subsequent failure will be condoned except programmes in Group 'I'.
- (ix) Students who pursue their studies through correspondence programmes are also eligible. The term correspondence includes distant and continuing education.
- (x) Employed students whose income combined with the income of their parents/guardians does not exceed the maximum prescribed income ceiling are made eligible to post-matric scholarships to the extent of reimbursement of all compulsorily payable non-refundable fees.
- (xi) All children of the same parents/guardians will be entitled to receive benefits of the scheme.
- (xii) A scholarship holder under this scheme will not hold any other scholarship/stipend. If awarded any other scholarship/ stipend, the student can exercise his/her and should inform the awarding authority through the Head of the Institution about the option made. No scholarship /stipend whichever is more beneficial to him/her and should inform the awarding authority through the head of the Institution about the option made. No scholarship will be paid to the students under this scheme form the dates he/she accepts another scholarship/stipend. The students can however, accept free lodging or a grant or adhoc monetary help form the state Government or any other source for the purchase of books, equipment or for meeting the expenses on board and lodging in addition to the scholarship amount paid under this scheme.
- (xiii) Scholarship holders who are receiving coaching in any of the pre-examination training centers with financial assistance form the Central Government/ State Government will not be eligible for stipend under the coaching schemes for the duration of the coaching programmer.

Note: It is mentioned under the item III (condition of eligibility) of these regulations that the

Scholarship will be given for the study of all recognized post-matriculation or post-secondary programmes pursued in recognized institutions, the list of programmes grouped (1 to IV) is only illustrative and not exhaustive. The State Governments/ Union territory Administrations are, thus, themselves competent to decide the appropriate grouping of programmes at their level as advised vide this Ministry's letter No. 11017/13/88 Sch Cell, dated 3.8.1989.

II. OTHER CONDITIONS FOR THE AWARD

- 1. The scholarship is dependent on the satisfactory progress and conduct of the scholar. If it is reported by the head of the Institution at any time that a scholar has by reasons of his/her own act of default failed to make satisfactory progress or has been guilty of misconduct such as resorting to or participating in strikes, irregularity in attendance without the permission of the authorities concerned etc, the authority sanctioning the scholarship may either cancel the scholarships or stop or withhold further payment for such period as it may think fit.
- 2. If a student is found to have obtained a scholarship by false statements, his/her scholarship will be cancelled forthwith and the amount of the scholarship paid will be recovered, at the discretion of the concerned State Government. The student concerned will be blacklisted and debarred for scholarship in any scheme forever.
 - i) A scholarship awarded may be cancelled if the scholar changes the subject of the programme of study for which the scholarship was originally awarded or changes the Institution of study, without prior approval of the State Government. The Head of Institution shall report such cases to them and stop payment of the scholarship money. The amount already paid may also be recovered at the discretion of the State Government.
 - ii) A Scholar is liable to refund the scholarship amount at the discretion of the State Government, if during the programme of the year, the studies for which the scholarship has been awarded, is discontinued by him/her.
 - iii) The regulations can be changed at anytime at the discretion of the Government of India.

III. PROCEDURE FOR APPLYING

An application for scholarship should comprise:

- i. One copy of the application for scholarship in the prescribed form (separate application forms as have been prescribed for 'fresh' and renewal scholarship by concerned State/UTs)
- ii. One copy of the passport size photograph with signature of the student thereon (for fresh scholarship)
- iii. One attested copy of certificates, diploma, degree etc in respect of all examinations passed.
- iv. A certificate (in original) of caste duly signed by an authorized Revenue Officer not below the rank of Tehsildar.
- v. An income declaration by the self-employed parents/guardians, stating definite income from all sources by way of an affidavit on non-judicial stamp paper. Employed parents/guardians are required to obtain income certificate from their employer and for any additional income from other sources. They would furnish declaration by way of an affidavit on non-judicial stamp paper. Scholarship will be paid to the student whose parents/guardians income from all sources does not exceed **Rs. 2,50,000/-** per annum.
- vi. A receipt in acknowledgement of the scholarship in previous year on the form attached to the application only duly counter-signed by the Head of the institution concerned, it the application was in receipt of a scholarship under this scheme in the preceding year.
- vii. Application complete in all respects shall be submitted to the Head of the Institution, being attended or last attended by the candidates and shall be addressed to an officer specified for this purpose to the Government of State/union territory to which the student belongs, in accordance with the instructions issued by them from time to time.

 - **Note:** The BC students may also apply for Post Matric Scholarship whose parents' annual income from all sources is less than **Rs. 2,50,000/-** per annum. They will be paid maintenance allowance only
