<u>Minutes of the meeting of committee held on 14.06.2023 at 11:00 AM</u> in the Room No. 36, Lal Bahadur Shastri Bhawan, Administrative Block, CDLU, Sirsa.

In compliance of the orders of Hon'ble Punjab and Haryana High Court in CWP No. 19962 of 2017 *titled as "Saroj Mehta V/s State of Haryana & Others", a* meeting of the following Committee constituted by the Executive Council vide Resolution No. 71.22 in its 71st meeting for implementation of the orders of the Hon'ble Punjab & Haryana High Court and to examine the implications of the orders and to give suggestions in this regard was held on 14.06.2023:

The minutes of the meeting held on 25.05.2023 re-considered and re-viewed and also perused the following record produced by the Establishment Branch:

- A. The Committee perused the contents of the writ petition, reply submitted by the University and orders of Hon'ble Punjab and Haryana High Court in CWP No. 19962/2017 titled as Saroj Mehta V/s State of Haryana & Others.
- B. The Committee perused the Notification No. Estt.NT/2023/O-86/Vol.VII/1578-1660 dated 29.05.2023 regarding complying the orders for quashing the notification dated 06.07.2017.
- C. The Committee perused the relevant record to examine the implications of the orders of Hon'ble Punjab and Haryana High Court in CWP No. 19962/2017 titled as Saroj Mehta V/s State of Haryana & Others.
- D. The Committee perused the various promotion channels which were notified vide No. Estt./17/AE-III/O-164/5272-5325 dated 06.07.2017.
- E. The Committee also gone through the earlier minutes of the committee dated 02.08.2021 which were approved by the Executive Council in its 64th meeting held on 03.08.2021.
- F. Representation dated 29.05.2023 submitted by Sh. Madan Singh, Legal Assistant.
- G. Resolution No. 74 of 45th meeting of Executive Council held on 05.03.2014 of Chaudhary Devi Lal University, Sirsa, which is reproduced as under:-

"Considered and approved the adoption of the Calendars Vol-I, II & III prescribed by K.U. Kurukshetra by this University to the extent where the rules of CDLU Sirsa are not available in its own Calendars. Further decided that the rules of the State Government will be applicable in case the rules do not exist in CDLU Sirsa and the K.U. Kurukshetra".

J. Terms & Conditions as approved by the Executive Council in its **26th** meeting held on **07.12.2008** regarding Terms & Conditions of absorption of nonteaching employees of the University.

After going through the above mentioned documents and after detailed discussion, the Committee unanimously recommended that:

- 1. The cases of employees appointed through **direct recruitment** for seniority and promotion against available budgeted post(s) may be considered in the light of existing rules of Chaudhary Devi Lal University, Sirsa/Kurukshetra University, Kurukshetra/Govt. of Haryana and as per order of the merit of the selection panel/date of joining as well as date of confirmation of service against the post they were appointed.
- 2. The cases of employees taken **on deputation** for claiming the seniority and promotion against available budgeted post(s) may be considered :
 - a) On the basis of their date of absorption in Chaudhary Devi Lal University, Sirsa and/or
 - b) As per terms and conditions of their absorption indicated in their appointment letter.

If the date of absorption is same, then length of service in a particular post/grade in Chaudhary Devi Lal University, Sirsa will be considered. In case of date of absorption of employees taken from a particular/same institution on the particular/same post/grade is same then their inter-se-seniority shall be decided on the basis of their seniority in their parent institution(s).

- 3. In cases of those employees, who have not been appointed against budgeted post or where promotional channels do not exist, such employees cannot be considered for further promotion except granting them ACP from time to time as per Govt. Rules.
- 4. The committee is also of the view that post wise seniority of incumbents may be relooked/re-cast in compliance of the orders of Hon'ble Punjab and Haryana High Court in CWP No. 19962 of 2017 *titled as "Saroj Mehta V/s State of Haryana & Others"*.
- 5. The Committee examined the representation dated 29.05.2023 submitted by Sh. Madan Singh, Legal Assistant w.r.t. the decision dated 23.03.2023 in CWP No. 19962/2017 titled as Saroj Mehta Vs State of Hry. etc. and found that there is no merit in matters detailed by the employee in his representation, therefore, it can not be acceded to.
