Guidelines for Special Counseling:

- **31.** Admission through Special Counseling: In case seats remain vacant after physical counseling a special online/offline counseling will be held and admission will be offered to the candidates on the basis of the merit on a schedule provided by the competent authority:
 - a. The candidates who applied for admission in the department and fulfill minimum eligibility conditions but their name did not appear in the provisional admission list in the previous three counselings.
 - b. Any candidate who applied for admission and whose name appeared in the provisional admission lists but failed to deposit his/her fee.
 - c. Any fresh candidate who is eligible and has submitted his application through any mode after the expiry of the last date notified for admission but not after the last date of admission in the University.
