It is to inform you that a letter received from the Joint Director Scholarship for Director General Higher Education, Haryana, Panchkula vide Memo No.06/23-2025 SCH 3 (b) dated 15.09.2025 (copy attached) stating that the Social Justice Empowerment welfare of Scheduled Castes & Backward Classes and Antyodaya Department, Haryana and Govt. of India has decided that the onboarding process for the scheme titled Post Matric Scholarship (PMS) for scheduled caste and Post Matric Scholarship for other Backward Classes & Denotified Tribes (DNTs) is to be initiated on the National Scholarship Portal (NSP) for the academic year 2025-26. 


