Keshni Anand Arora, Chief Secretary, taking decision for the needed amendment in the entry qualification of higher education courses in respect of ITI pass outs (further to 12th equivalency provided to ITI graduates by Haryana Boards of School Education) was read out and it was resolved to be incorporated into the HBI and Instruction/Guidelines for admissions.

- i) For referred decision of the committee in its meeting held on 03.06.2020 with regard to comply the decision of the Hon'ble Supreme Court order dated 15 December, 2017 passed in the W.P. (.C) No. 292/06 titled "Disabled rights Group & Anr. Vs. UOI & Ors." the provision of Section 32 of the Rights of Persons with Disabilities Act, 2016, it was resolved that the following be incorporated into the HBI and Instruction/Guidelines for admissions for the session 2020-21:
 - a) All Government institutions of higher education and other higher education institutions receiving aid from the Government shall reserve not less than five percent seats for persons with benchmark disabilities.
 - b) The persons with benchmark disabilities shall be given an upper age relaxation of five years for admission in institutions of higher education.
- ii) Regarding Mooc Coordinator/Assistant Coordinator, the matter may be decided by the Hon'ble Vice Chancellor.
- iii) One member from Department of Physical Education, be nominated to the HBI & Instruction Guidelines for Admission Committee, as per the precedent followed by the University.
- iv) Admissions for University college will also be included in Main HBI 2020-21 and Principal of University College be also member of the HBI and Instruction /Guidelines Committee for the Session 2020-21.
