The Vice-Chancellor is pleased to approve the following recommendations of the committee, constituted under the convenership of Prof. R.K. Salar, COE, CDLU, Sirsa in pursuance to the decision of the Academic Council, taken vide Resolution No. 35 (vii) in its meeting held on 20.04.2021, to suggest the matter of evolving a uniform system for practical examinations for all undergraduate courses of meeting was held on 25.05.2021 at 11:00 AM in the Office of COE, CDLU, Sirsa:

The Principal GNC, Sirsa and member of the committee apprised that conducting of practical examinations semester wise cause a lot of disturbance of theory classes sufficiently and the same may be reviewed. He appraised that presently in some courses practical examinations are conducted annually. While in some courses it is conducted semester wise. He suggested that while revising the syllabus and scheme of UG courses, the UGBOS concerned may adjust the practical exams with even semester (2<sup>nd</sup>,4<sup>th</sup> & 6<sup>th</sup>) enabling the University to devise a uniform system for practical examinations in UG courses.

The Committee is of the view that the practical exams for UG courses may be conducted annually with even semester exams to maintain uniformity in practical exams. The committee recommends that while revising the syllabus of UG course, the UGBOS concerned may adjust of practical examinations on annual pattern with even semester examination in order to maintain uniformity in practical exams. The recommendations may be placed before the Academic Council accordingly for its consideration.
