Dr. K.C.Bhardwaj, Vice-Chancellor of the University and Chairman, Executive Council welcomed the members to the meeting.

To start with Dr. D.S. Mor, Director-Principal, Chaudhary Devi Lal Memorial Engineering College, Panniwala Mota pointed out that he was present in the last meeting of the Executive Council held on 21.11.2009. However, his name was not mentioned in the list of members present in the meeting. This has been noted and rectified in record. Thereafter, the agenda item was taken up.

1. **Confirmed** the minutes of the 30th meeting of the Executive Council held on 21.11.2009, with the following modifications/corrections:-
 - (a) The word 'Social Science' be replaced with the word 'Sociology' at Sr. No. 3 in Resolution No.6.
 - (b) The nomenclature of the course mentioned at (i) in Resolution No. 8 be changed to as is prevalent in KUK/MDU.
 - (c) Resolution No. 39 (i) be treated as withdrawn.



(d) Resolution No.7 be modified as "Resolved to adopt the rules and rates of remuneration, in toto, for Guest Faculty as prescribed by KUK, which will be applicable from the session 2009-10."

2. Noted the follow up action on the decisions taken in the previous meeting held on 21.11.2009. The council also took the following decisions while noting the follow up action:

(a) The Council authorized the Vice-Chancellor to take decision in the case of Dr. Rajbir Singh Dalal, Reader and Dr. Surender Mor, Lecturer, as mentioned in resolution No. 31.

(b) The following committee is constituted to examine the case of Dr. Joginder Singh Duhan, Lecturer, Department of Biotechnology as mentioned in resolution No.34:

3. Considered the proposal that Dr. (Mrs.) Anu Shukla, Professor in English may be granted Extra Ordinary Leave (without pay) for a period of Five and Half months, from the date she is relieved in order to enable her to join as Professor in English, Department of English, Central University of Haryana, Villages (Jant-Pali), Mahendergarh, Haryana.

Dr. (Mrs.) Anu Shukla left the meeting when this item was taken up.

Resolved to approve the above proposal.

4. Considered the action taken by the Vice-Chancellor under Section 11(6) of the University Act in revising the qualification for the post of Coach as under:

8. Considered the recommendation of Selection Committee for engagement as Lecturer in Hindi made in its meeting held on 13.12.2009.
