At the outset, the Vice-Chancellor welcomed the newly constituted Executive Council. Thereafter, the agenda was taken up.

1. **Considered the recommendations of the Academic Council in its meeting held on 13.01.2012 regarding the proposal for the conferment of degrees in the 1st Convocation as under:**

1. The degrees of Ph.D. may be awarded by the Hon'ble Chancellor during the Convocation.
2. The degrees of Master of Philosophy/Post Graduate/Under Graduate examinations be awarded by the Vice-Chancellor.
3. All the candidates of University Teaching Departments who have obtained 1st Division in May 2011 examination be invited for the award of degree.
4. Only the Gold Medalists of May 2011 (through Regular Mode) be invited in the Convocation and the Gold Medals be awarded by the Hon'ble Chief Minister.
5. Gold Medal/Degrees of remaining candidates (Regular Mode and Distance Education Mode) be sent to the candidates through concerned Department/UCDL.
6. Date of conferment of degree should be the date of Convocation instead of 31.12.2011 as already approved by the Academic Council.

RESOLVED to approve the above recommendations of the Academic Council.
