The Council considered the agenda and took following decisions:

1. The minutes of the 4th meeting held on 21.7.2004 circulated vide letter No. Acad/04/13282-92 dated 15.9.2004 were confirmed.
2. The follow up action taken report of the 4th meeting held on 21.7.2004 was noted.
3. Considered the action taken by the Vice-Chancellor under Section 11(6) of the University Act in appointing the following Professors for the post indicated against each till further orders not exceeding one year:

1. Prof..S. C. Kundu Dean, Academic Affairs. He will look after the academic activities and also the responsibilities of Dean of Colleges.
2. Prof. Manoj Dayal Dean, Students' Welfare. He will also discharge the responsibilities of Proctor.

Approved the action taken by the Vice-Chancellor under Section 11(6) of the University Act.

4. Considered the recommendations of the Committee constituted by the Vice-Chancellor in pursuance of Executive Council's Resolution No. 8 of its meeting held on 21.7.2004 regarding absorption of non-teaching employees who were taken on deputation from other Govt./University/organisation.

The Council decided to defer the case.

5. The Council approved the deputation of the following officers of the Haryana Govt. with this university for the period indicated against each:

1. Shri S. K. Sharma, Executive Engineer two years
 2. Shri Baljit Singh Sangwan, S.D.E. two years
 3. Shri Anil Kumar Walia, Architect two years
 4. Shri V. K. Jhamb, S.A.O. one year
6. The Council approved the action taken by the Vice-Chancellor under Section 11(6) of the University Act in refunding the fee of Rs. 29,576/- to Ms. Swati D/o Dr. J. K. Sharma, Professor Department of Chemistry, GJU, Hisar for M. Tech. Computer Science course for the session 2003-04, after deducting Rs. 5,000/-.
7. The Council approved the action taken by the Vice-Chancellor under Section 11(6) of the University Act in prescribing qualifications for various non-teaching posts in the University, as per the annexure-II page No. 13-14 of the agenda.
8. Considered the status report regarding the appointment of teachers who were recommended by the properly constituted Selection Committees and whose selections were approved by the Executive Council vide Resolution No. 3 of its meeting held on 21.7.2004 and took the following decisions:

9. The Council considered the status report of construction works in the University and noted that the progress was satisfactory.
10. The Council considered the status report of the examinations conducted by the University during April-2004 and appreciated the efforts made by the Vice-Chancellor in devising innovative methods for conducting the UG & PG examinations of the University for the first time on such a large scale. The Council also appreciated the efforts made by the Vice-Chancellor together with the Controller of Examinations and the other employees of the University in expediting the clearance of RL cases.
11. Any other item:
 - i) The Council nominated Prof. D. V. S. Verma, Director-Principal & Dean, Faculty of Engineering & Technology, CDLU, Sirsa as its nominee on the Establishment Committee, wherever required, for conducting the selections of non-teaching posts.
 - ii) The Council approved enhancement of TA by own car/taxi from Rs. 5/- to Rs. 6/- per km in view of the Haryana Govt. instructions.
 - iii) The Council placed on record the services rendered by Dr. R. C. Punia as Secretary of the Executive Council, and appreciated his efforts in the smooth conduct of its meetings.

The meeting ended with a vote of thanks to the Chair.
