24. Any Other Item.

- The Students should prepare the project work individually on different topics. The project prepared jointly by some students of M.Sc. 4th Semester Biotechnology and Energy & Environmental Sciences departments may be got examined this time as a special case, so that students may not suffer and results be declared accordingly as they have already left the University. In future, Department concerned will make necessary amendments in the syllabus and project may be planed in such a way that every student submits his/her project report on different topic.
- The Chairman, Department of Economics requested to enhance the intake in M.Phil course by five seats and informed that Dr. Prem Chand Kamboj, Lecturer, Govt. National PG College, Sirsa will guide the regular scholars for their research & dissertation work. Existing seats in M.Phil are sufficient as per eligible teachers available in the Department. As per decision of the Ph.D/M.Phil ordinance committee meeting held on 03.08.2009 that number of seats in M.Phil course in particular UTD shall be no more than five multiple by the total number of eligible teacher available in the department. Teacher other than the Department can not guide/ supervise regular students of the University for their M.Phil dissertation.
