At the outset, the Vice-Chancellor welcomed the Members of the Academic Council. As Dr. Rakesh Wadhwa, Registrar was not available, the house decided to appoint Prof. S.K. Gahlawat, Dean Academic Affairs to act as Secretary also for this meeting. Professor Ajmer Singh Malik, Vice Chancellor updated the house about the academic activities carried out in 2021 and adoption of National Education Policy-2020 based academic programs in University School for Graduate Studies. He has also appreciated the efforts made by the Faculty Members of the University in launching NEP-2020 successfully and revising the curriculums as per Learning Outcomes based Curriculum Framework of all Post Graduate Programmes running in University Teaching Departments and Graduate Programmes in USGS. Thereafter, the agenda items were taken up.
