MEMORANDUM OF UNDERSTANDING BETWEEN LALA LAJPAT RAI UNIVERSITY OF VETERINARY AND ANIMAL SCIENCES, HISAR AND CHAUDHARY DEVI LAL UNIVERSITY, SIRSA.



1. THE AGREEMENT

1.1. THE AGREEMENT made and entered into on 14-08-18 between Lala Lajpat Rai University of Veterinary and Animal Sciences, Hisar (hereinafter called LUVAS, Hisar) which expression shall, where the context so admits, include its employees and officers, of the one part

AND

1.2. Chaudhary Devi Lal University, Sirsa (hereinafter called CDLU, Sirsa) which expression shall, where context so admits, include its employees and officers of other part

2. PREAMBLE

2.1. WHEREAS LUVAS, Hisar has developed a unique facility for research in the areas of Veterinary and Animal Sciences and has eminent faculty.

- 2.2. WHEREAS CDLU, Sirsa has developed a unique facility for research in the areas of Biotechnology, Food Science & Technology, Environmental Sciences, Chemistry, Physics, Computer Sciences etc. and has eminent faculty.
- 2.3. AND WHEREAS LUVAS, Hisar and CDLU, Sirsa agree to extend mutual cooperation on terms and conditions hereinafter contained.

3. SCOPE OF AGREEMENT

- 3.1. This Agreement details the modalities and the terms and conditions for academic cooperation between LUVAS, Hisar and CDLU, Sirsa the rights and obligations of either PARTY there to and other arrangements between the parties.
- 3.2. The MoU shall come into force from the date of signing of this agreement (hereinafter called the effective date) and shall remain valid for 5 years or until superseded or cancelled.
- 3.3. This MoU will be applicable for faculty and PG students of LUVAS, Hisar and CDLU, Sirsa for academic and research work and vice versa.

4. RESPONSIBILITIES OF LUVAS, HISAR AND CDLU, SIRSA

- 4.1. CDLU, Sirsa shall recognize LUVAS, Hisar as an academic and research centre at par with the academic departments of CDLU, Sirsa and faculty of LUVAS, Hisar at par with faculty of CDLU, Sirsa for academic and research work and vice versa.
- 4.2. Both the collaborating Universities will provide opportunities to PG students to conduct research in their laboratories. Time spent at LUVAS, Hisar/CDLU, Sirsa by the Ph.D students shall be counted for the purpose of determining residential requirement of CDLU, Sirsa/LUVAS, Hisar. LUVAS students will be required to nominate a faculty member of CDLU, Sirsa as Co-Major Advisor and CDLU, Sirsa students will be required to nominate a faculty member of LUVAS as Co-Supervisor who will be signatory as Co-Supervisor in the synopsis and thesis. In addition, they will be required to complete Ph.D. course work/ Pre Ph.D prescribed by LUVAS, Hisar / CDLU, Sirsa.
- 4.3. The necessary chemicals/consumables, if required, shall be provided by the collaborating University subject to availability of funds without affecting the normal working of the respective departments. The cost and expenditure or Project contingencies will be shared by mutual consent. Major Advisor of PG student's will plan and arrange necessary funds for laboratories, supplies before getting the students' synopsis approved.
- 4.4. The student shall submit a copy of his/her thesis to the LUVAS, Hisar/CDLU, Sirsa Library.
- 4.5. The student shall be required to submit 'No Dues Certificates' from the department of Co-Major Advisor/Co-Supervisor before the University allows submission of thesis.
- 4.6. LUVAS, Hisar and CDLU, Sirsa shall allow the Library and other facilities to be used by the faculty of collaborating University for academic activities by following University rules.

4.7. Postgraduate degree will be awarded by CDLU, Sirsa/LUVAS, Hisar as per its own rule/regulations.

4.8. LUVAS, Hisar/CDLU, Sirsa shall allow its infrastructure and facilities to be used by the students registered for PG students in CLDU, Sirsa/LUVAS, Hisar for his/her research activities, wherever faculty member of collaborating University is on the Advisory Committee of PG student.

4.9. CDLU, Sirsa/LUVAS, Hisar shall provide training/project work to Post-graduate students of Masters' and Ph.D. students (maximum twenty students in one academic session and maximum of two students for one faculty member) of LUVAS, Hisar/CDLU, Sirsa depending upon the available facilities.

4.10. The students will be allowed to utilize the scientific material and physical facilities of each other University with the approval of the Head of the concerned department and

it will not hinder the normal working/functioning of the University.

4.11. Both LUVAS, Hisar/CDLU, Sirsa shall ensure that the student submits at least one paper from Master's thesis and two papers from Ph.D. thesis before thesis submission in order to prevent students leaving the institute(s) without any research publication from the thesis.

5. INTELLECTUAL PROPERTY

Intellectual property, research publications and benefits arising out of commercialization of technologies generated out of co-operation under this agreement shall be jointly owned by LUVAS, Hisar and CDLU, Sirsa or as per guidelines of the funding agency on mutually agreeable terms.

6. TERMINATION OF AGREEMENT

The MoU shall be effective form the date of its signing by both the parties and shall remain in operation for 5 years or until either Party serves notice to the other for its intension to terminate it. In such events, the MoU shall stand terminated at the end of one calendar month from the date of issue of such notice. In case both the Parties agree to terminate the MoU, the on-going thesis or research work shall be allowed to be completed.

7. AMENDMENTS TO THE AGREEMENT

The Parties to this MoU may, by mutual consent, add, modify, amend or delete any word, phrase, sentence or article in this MoU at any time during the operation of MoU.

8. SETTLEMENT OF DISPUTE ETC.

The Parties could act strictly according to the provisions of law while implementing this MoU. In case there is any dispute regarding any matter arising from this agreement or from the interpretation of MoU, the matter/dispute will be settled through arbitration by

The courts at Hisar/ Sirsa have jurisdiction to hear the matters/dispute which may arise under this MoU.
