At the outset, Hon'ble Vice-Chancellor welcomed the Members of the Executive Council. Thereafter, agenda was taken up and resolved as follows:

Resolution no. 37:

Resolved that seniority of non teaching employees will be decided subject to final outcome of court case(s) instead in light of pending court cases". The decision of Executive Council will be subject to any decision/direction(s) of Hon'ble Punjab & Haryana High Court in the matter of seniority of non-teaching employees.

Resolution no. 38:

Considered and resolved that the observation of Prof. (Dr.) K.P.S. Mahalwar the then Member of the Executive Council be made part of the minutes of the Meeting. The case was discussed thoroughly and it was decided unanimously to file the case as all the accused have been acquitted by the court. - 32. The proposal for creation of posts for University Printing Press, proposed by the committee constituted by the Vice-Chancellor was considered and not approved.
 - Further resolved that the establishment of printing press in the University is not viable option and the printing work be got done from outside or local market.
- 33. Considered and approved to adopt the guidelines for engaging Senior Academicians/Officers as Distinguished Visiting Faculty in Higher Education

Institutions as per norms of UGC issued vide letter no. F-9-1/2010(PS/MISC) Pt.VOL.II 3rd June, 2019 forwarded by Director General, Higher Education Haryana vide memo no 18/2013-2019UNP(4) dated 02.08.2019with effect from the date of adoption of this notification by the Executive Council.

34. Considered and approved part 'A' of agenda i.e. Stage-I to Stage-II (AGP of Rs. 6,000/- to Rs. 7,000/-) to Dr. Rajiv Vij and Dr. Maya Devi, Assistant Librarians, University Library on the recommendations of Screening-cum-Evaluation Committee for upward movement under Career Advancement Scheme (CAS).

Further, resolved that the case at part B of agenda of Dr. Rajiv Vij, Assistant Librarian from Stage-II to Stage-III be placed later on.

Considered and resolved that Ms. Sakshi Dhingra, Assistant Professor (on deputation) should be relieved form this university as per decision of the Executive Council of Guru Jambheshwar University of Science & Technology, Hisar as conveyed vide letter no. F-1/20/7831 dated 21.05.2020 and her salary should be released against the budgeted post.
- 38. Before considering the recommendations of the Establishment Committee for promotion of Dr. Saroj Mehta, Programmer to the post of System Manager, Dr. Omda Kumar and Sh. Ram Chander Moury, Deputy Superintendents to the post of Superintendent, the Executive Council perused the interim orders of Hon'ble Punjab & Haryana High Court dated 17.06.2020 in CWP No.7187 of 2020. The contents of interim order is reproduced below:-

"Meanwhile, respondents No.3 and 4 be not promoted without finalizing the objections raised by the petitioners to the seniority list, annexure P-7".

Respondent No.3 is Mrs. Rashmi and respondent No.4 is Dr. Omda Kumar, Deputy Superintendents in this case.

In light of interim decision of Hon'ble Punjab & Haryana High Court the Executive Council perused all the documents of seniority of non-teaching employees. As per decision of 54th Meeting of EC held on 27.02.2019 vide resolution No.37 it was decided that the seniority list of non-teaching employees be circulated. Accordingly, the Establishment Branch vide letter No. Estt./AE-IV/19/1206-1272 dated 09.04.2019 circulated the seniority list of non-teaching employees to all the Chairpersons and all Branch Officers of this University to get it noted from all non-teaching employees working under them. It was also mentioned specifically in the letter that the objections, if any, raised by the concerned employee(s) be sent to the Establishment Branch within 15 days from the date of issue of the above letter. After receiving objections from non-teaching employees the committee was asked by the competent authority to go through the objections received from non-teaching employees and resolve them and, then submit, the final seniority list of non-teaching employees.

The committee in its meeting held on 17.06.2020 submitted the final seniority list by considering all the objections raised by non-teaching employees. The same was placed before the House. After considering the seniority list the Executive Council resolved unanimously that the final seniority list of non-teaching employees submitted by the committee is accepted in toto and the decision of E.C. be conveyed to the petitioners in CWP No.7187 of 2020. The above resolution of the Executive Council will be subject to any direction(s)/decision of Hon'ble Punjab & Haryana High Court in the matter of seniority of non-teaching employees.

After decision of the finalization of seniority of non-teaching employees by the Executive Council the recommendations of Establishment Committee Meeting held on 11.03.2020 for the promotion of Dr. Saroj Mehta, Programmer to the post of System Manager, Dr. Omda Kumar and Sh. Ram Chander Moury, Deputy Superintendents to the post of Superintendents were approved on the basis of seniority.

Further, it was resolved that qualifications and criteria required for promotion be also supplied to the members of the Executive Council alongwith agenda item(s) in future.

Prof. Raj Kumar Siwach, Dean Academic Affairs expressed his reservation for promotion of respondent No. 4 as the matter is sub-judice vide CWP No.7187 of 2020.

Internet connectivity disturbed during discussion, therefore, telephonic consent of Hon'ble E.C. members was taken.

Any other item(s):

Due to disturbance of Internet connectivity telephonic consent of Hon'ble members of the Executive Council was also taken on the following items.

1. Executive Council authorised the Vice Chancellor to give two names for Search Committee to prepare a panel for appointment of the Vice-Chancellor of Ch. Devi Lal University, Sirsa.

2. Executive Council authorised the Vice-Chancellor to assign the duties of Dean Academic Affairs, Dean of Colleges, Dean Students' Welfare, Director Centre for Information Technology, Proctor etc. The same will be reported to the Executive Council in its next meeting.

Further, it was decided that the remaining items of the agenda along with further agenda item(s), if any, will be put up in the next meeting of the Executive Council. Hon'ble members were informed, accordingly.
