Dated, Chandigarh, the 31.08.2020

Whereas in the light of orders issued by the Ministry Home Affair, Govt. of India vide no. 40/3/2020-DM-1(A) dated 29.07.2020, it has been decided by the State Government that all Higher Educational Institutions shall remain closed for students and regular class activity till 30.09.2020. During this period the following guidelines shall be adhered to:

1. E- Learning for the students may be continued.
2. The Staff in the Universities and Colleges will come as per the usual protocol for completion of academic & administrative works. However, all precautionary measures as notified by MHA, GOI be followed meticulously.
3. Efforts shall be made that online classes are started from 15.09.2020.


