NOTIFICATION

A meeting of all Deans of the Faculties, Chairpersons/In-charges of UTDs and Principal, University College under the Chairmanship of the Vice-Chancellor was held on 11.05.2021 at 11.30 am through online mode to finalize the following issues:

1. To start the online teaching w.e.f. 17.05.2021 in all UTDs and University College.
2. Conduct of mid term examinations in 1st week of June through online mode.
3. Payment of salary to the Part Time Teachers in lieu of online teaching.
4. Any other item with the permission of the Vice-Chancellor.

In the meeting, the following was resolved:

1. Vacations declared vide letter No. CDLU/2021/Spl.-2 dated 01.05.2021 stands cancelled w.e.f. 17.05.2021. The teachers will carry out online teaching w.e.f. 17.05.2021 as per the time table decided by the respective department and the teachers will maintain the record/link of online classes.
2. The even semester/terminal semester examinations will be held from first week of July for PG courses and university campus courses. Further, the practical examinations for these semesters will be conducted offline but in small groups and in between 11-25 June, 2021.
3. As far as conduct of practical of first and third semester, which could not be conducted so far is concerned, the same should be conducted before 10th June, 2021, if circumstances allow through the internal or external examiner. In case the Chairperson is willing to conduct the practical by the internal examiner due to non-availability of external examiners, the permission be sought from the Vice-Chancellor well in advance.
4. The University Teaching Departments/University College will conduct the mid term examinations before 20th June, 2021 through online/offline mode.

5. Part Time Teachers will be paid remuneration in lieu of their online teaching from 17.05.2021 onwards.
6. Viva-voce of M.A./M.Com./M.Phil./Ph.D. can be conducted through online mode with the specific permission of the Vice-Chancellor.
7. The teachers who have not completed evaluation work so far are directed to complete it by 17th May, 2021, otherwise the Controller of Examinations is empowered to withdraw answer booklets with due intimation to higher authority.
8. Regarding CBCS and LOCF guidelines, Deans of the Faculties are requested to check the syllabus for uniformity alongwith Chairperson of the concerned Department(s). Further, the following will monitor the uniformity in the syllabi of various departments:
 - (a) Dean Academic Affairs and Dean Faculties of Life Science for all science subjects.
 - (b) Dean Faculty of Humanities for all subjects of Humanities.
 - (c) Dean Faculty of Social Sciences for all subjects of Social Sciences.
9. The Chairpersons are allowed to convene the meetings of Staff Council/DRC etc. through online mode, if required.
