Minutes of the meeting of Fee Committee held on 04.06.2018 at 2:30 p.m. in the office of Dean of Colleges, Administrative Block, Chaudhary Devi Lal University, Sirsa.

The committee members discussed the issues at length and recommended as under:


- Take action as per separate approval obtained by Principal of University College.
1. For the Academic Session 2018-19 University College will be functional with following five new professional and Job-oriented programmes with fees @ Rs.20,000/-per semester with intake of 80 seats in each programme.
    - i) BBA (Health Care and Hospital Management)
    - ii) B. Com. (Taxation and Tax Practice)
    - iii) B. Com (Honours)
    - iv) B. Sc. (Fashion Technology)
    - v) B. Sc. (Food Technology and Management)
  2. At the instance of the Dean Students' Welfare, the Group Insurance Scheme contribution of students have been increased to @ Rs.60/- per student from an existing Rs.50/-per student.
  3. The committee has observed that there was a typographical error in the previous minutes as the entry of Rs.100/- as e-suvidha fee was shown in each semester where as it was being charged only once a year. Hence, the entry in the 2<sup>nd</sup> semester be dropped. It, however, does not affect the total amount of fee in any semester. It may be called **Annual e-suvidha fee** @ Rs.100/-per year.
  4. The Committee considered the minutes of the meeting held on 17.12.2016 under the Chairmanship of Director General Higher Education, Haryana and resolved that NSS fee for the session 2017-18 be charged as per actual. For next session NSS Fund/Fee may be charged @ Rs. 20/- per student per annum and be shared equally among the University and affiliated College.


5. The Committee has unanimously resolved that 100% share of the Development Fund charged by the affiliated B.Ed. Colleges of Sirsa and Fatehabad Districts shall be deposited in the University Account and Registration & Scholarship Branch be directed to accept the Registration Return of these colleges on production of a proof in this regard.
6. The Accounts Branch may be requested to start/operationalize the online Payment Gateway to accept/receive the all types of fees charged by the University.
7. The Committee unanimously resolved that the Youth Welfare Fee shall be charged Rs.200/-from each student. The affiliated colleges shall deposit 50% share and the UTDs shall deposit 100% share in DYW account respectively.
8. The Committee unanimously resolved that the Sports Fee shall be charged Rs.150/-from each student out of which the affiliated colleges and UTDs shall deposit Rs.100/- in University Sports Council Account and the Rs.50/- of UTDs shall <sup>be</sup> deposited in DSW Amalgamated Fund.
