At the very outset Registrar welcomed the members and introduced the new Vice Chancellor to the members of the Council.

Members of the council welcomed the appointment of Dr. K.C. Bhardwaj as Vice-Chancellor of Chaudhary Devi Lal University, Sirsa and resolved to convey their gratitude in this regard to His Excellency the Governor- Chancellor and the Government of Haryana.

The Council appreciated the services of Shri R.R. Fuliya as the Vice Chancellor of this University.

The Council discussed the agenda in a cordial ambience and took the following decisions unanimously:

1. The Council noted the appointment of Dr. K.C. Bhardwaj as Vice Chancellor of Chaudhary Devi Lal University, Sirsa.
2. The Council confirmed the minutes of previous meeting held on July 3, 2006. As regards the advancement of joining of Dr. Sultan Singh, Reader Department of Business Administration is concerned, a review committee comprising of the following members was constituted:
 - i) Dr. S.S. Dhillon, Member of the Executive Council
 - ii) Dr. J.S. Jakhar, Member of the Executive Council

3. Noted the follow up action taken on the decisions of the Executive Council in its previous meeting held on July 3, 2006. The council desired that the enquiry against Sh. O.P. Dhaka, Ex- Deputy Registrar of this University be completed on priority.

4. On recommendations of the Academic Council vide resolution no. 12 of its meeting held on 04-09-2006, the Council considered and approved the proposal for the establishment of an Institute of Professional and Scientific Studies & Research for introduction of Job Oriented Professional courses under self financing scheme.

The Council also considered and approved the rules for administration and governance of self-financing scheme.

5. The Council considered and approved the appointment of employees on deputation and that after superannuation.

6. The Council considered and approved the guidelines for procurement of articles and equipments in Chaudhary Devi Lal University and also approved the constitution of the High Powered Purchase Committee and the Standing Purchase Committees.

7. The Council considered and approved the payment of remuneration for additional assignments of higher posts to the teachers/officers of the University.

In addition, the Council further resolved to authorise the Vice Chancellor to constitute a committee to study and make recommendations for determining additional remuneration for all additional assignments in addition to those approved above.

8. The Council considered and approved the proposal for creating the post of Director in the Professor's scale for the self financed Institute of Professional and Scientific Studies & Research The Council authorised the Vice Chancellor to secure the Bio-data of academicians for considering them for appointment as Director. Further, the Council unanimously constituted the Selection Committee comprising of the following to help the Vice Chancellor in appointing the suitable person as Director for this Institute:

Further, resolved to authorise the Vice Chancellor to appoint other candidates as recommended by Selection Committees based on the needs/requirements of the teaching department(s) concerned.

10. The Council considered and nominated Prof. S.S. Dhillon as the nominee of the Executive Council on the Establishment Committee in terms of Ordinance IX (3) of K.U. Kurukshetra Calendar Volume-I as adopted by this University.

11. The Council constituted the following committee to draft the Statutes, Ordinances/Rules and Regulations/Calendars for Chaudhary Devi Lal University, Sirsa:
