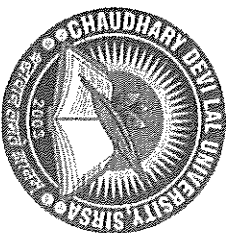

At the outset the Vice-Chancellor welcomed the Members to the meeting of the Executive Council. The Vice-Chancellor introduced Smt. Neelam Pardeep Kasni, IAS, Joint Secretary to Govt. Haryana, Finance Department to the Members of the Council. Thereafter the Agenda was taken up:-

1(A) Considered the Inquiry Report submitted by the Women Complaints Committee/Grievance Cell (WCC) of the University in connection with the complaint filed by Ms. Anita Muddgil, a student of M.A. II of the Department of Journalism & Mass Communication.

(B) Also considered the Inquiry Report in the above case submitted by Mrs. Sadhna Mittal, Protection Officer, Office of the Superintendent of Police, Sirsa, to the Deputy Commissioner, Sirsa

After great deal of deliberations, the Council unanimously resolved to approve as under:-

1) (i) Sh. Sewa Singh Bajwa, Lecturer, Department of Journalism & Mass Communication be placed under suspension and be charge-sheeted for major punishment on the basis of the above enquiry reports.

(ii) Sh. Amit Sangwan, Lecturer, Department of Journalism & Mass Communication be also charge-sheeted on the basis of the above enquiry reports.

(iii) Sh. Virender Singh Chauhan, Chairperson, Department of Journalism & Mass Communication be charge-sheeted for inordinate delay in reporting the matter to the University Administration.

(iv) That both the Enquiry Reports be sent to Superintendent of Police, Sirsa to take necessary action in case any criminal case is made out on the basis of these Enquiry Reports.

Most members of Executive Council pointed out that there may be serious irregularities in the functioning of the Department of Journalism & Mass Communication and Media Centre and Deputy Commissioner's Enquiry Report also mentioned that an enquiry be conducted regarding allocation of internal marks to the students in the Department of Journalism & Mass Communication. Therefore, the Executive Council unanimously resolved that a Committee be constituted for suggesting rules and procedure to be followed in the functioning of Media Centre and the manner in which Media Centre in the University is to be used and also enquire into the irregularities, if any, in the functioning of the Media

Centre as well as Department of Journalism & Mass Communication including the manner of allocation of internal assessment marks to the students:-
