

## **NOTIFICATION**

The Executive Council in its 61<sup>st</sup> meeting held on 28.01.2021 vide Resolution No. 14(i) has considered the matter related to the guidelines/rules and regulations for fixing remuneration of contractual and part time faculty members and authorized the Vice-Chancellor to follow the guidelines/rules and regulations of GJUS&T, Hisar in place of earlier decision taken by the Executive Council vide its resolution no. 11 of 60<sup>th</sup> meeting held on 13.11.2020 to grant equal pay for equal work.

Further, the Executive Council in its 61<sup>st</sup> meeting held on 28.01.2021 vide Resolution No. 14(ii) has considered and authorized the Vice-Chancellor to follow rules and regulation/provisions made by GJUS&T, Hisar for engaging contractual and part time faculty members. The earlier decisions taken by the Executive Council vide Resolution No. 12 of 57<sup>th</sup> meeting held on 20.06.2020 and Resolution No. 9 of 59<sup>th</sup> meeting held on 29.09.2020, in this regard have been rescinded.

Accordingly, the guidelines/rules and regulations of GJUS&T, Hisar are duly adopted to engage Guest Faculty/Part Time Teachers at CDLU, Sirsa on lecture basis to cover up the uncovered workload by the Departments/University College. The guidelines/terms are:

- 1. That the Part Time Teachers (in case of Ph.D. and NET holders) be paid @ Rs. 750/per lecture subject to a maximum of Rs. 35,000/- per month.
- 2. That the Part Time Teachers (other than sr. no. 01 above) be paid @ Rs. 750/- per lecture subject to a maximum of Rs. 30,000/- per month.
- 3. According to anti replacement theory created by the courts, one type of arrangement will not be replaced by a similar type of arrangement or akin to it provided their work & conduct and efficiency is not in doubt and workload is there.
- 4. The work and conduct of Part Time Teacher will be reported /supervised by the concerned Chairperson/s and Dean Academic Affair will be approving authority.
- 5. The work and conduct of the Part Time Teacher can be reported at any time/ at the end of session/ at the time of new session.
- 6. The disobedience/non-adherence of University orders/direction/ guidelines/rules/wil-ful absent from duty/indulging in illegal or immoral activities/ violation of engagement rules etc., shall be amount to misconducts and unbecoming of University Part Time Teacher.
- 7. The Vice-chancellor is the competent authority to approve panel of Part Time Teacher and de-panel of the same.

- 8. That the panel of Part Time Teachers has to be drawn by way of walk-in-interview by the University on the basis of the requirement of Part Time Teachers received from the University Teaching Departments/University College after assessment by the University.
- 9. That the arrangement of Part Time Teachers from the panel is only an assignment of workload purely on temporary basis to cover up uncovered workload in the concerned department/college and thus, no appointment letter, joining or relieving will be there and it is only assignment of work on lecture basis.
- 10. The remuneration is to be drawn on the basis of verification of attendance and work by the respective Chairperson/Principal.
