2. The application forms will be neatly and legibly filled in by the candidates in his own handwriting.
3. Name of the post applied for must be super-scribed at the top of the envelope as under: "Application for the post of \_\_\_\_\_".
4. Applications will be accepted only on prescribed format.
5. The candidates must ensure their eligibility as on the last date of submission of application form.
6. Separate application forms must be submitted for each position/post.
7. The downloaded application forms must be accompanied with a Demand Draft of prescribed form fee of Rs. 500/- (Rs. 125/- for SC, BC-A/BC-B.) in favour of Registrar, Chaudhary Devi Lal University, Sirsa payable at Oriental Bank of Commerce, Chaudhary Devi Lal University branch (IFSC Code ORBC0101517). 50% concession in fee is permissible for women candidates.
