AUCTION NOTICE

An open auction for disposal of unserviceable material lying at Administrative Block (belongs to M/s. NM Roof Designers Pvt. Ltd. Jaipur) will be held at Construction Branch, CDLU, Sirsa on 13.07.2020 at 12.00 P.M onwards. The terms and conditions of the auction are as under:

Terms and conditions:

1. The unserviceable material will be disposed – off on “as is where is” basis. The unserviceable material / list of material can be inspected / seen on working days during hours (10.00 a.m. to 4.00 p.m.) by contacting the Executive Engineer, Construction Branch.
2. Each Bidder will have to deposit an amount of Rs. 10000/- (Rs. Ten thousand only) as security money deposit in cash at the time of auction to become eligible for bidding. The security amount will be refunded to all the bidders except the highest bidder at the end of auction without interest.
3. The highest bidder shall have to deposit 25% of total cost of unserviceable material at the end of auction. The security money deposited can be adjusted in 25% deposit by the highest bidder. The highest bidder has to make full payment of total declared cost before lifting the material. The payment will be accepted in the shape of demand draft drawn in the favour of the registrar, CDLU, Sirsa payable at Sirsa or payment can be deposited at university cash counter. Money deposited shall be forfeited if payment in full is not made of the offer is withdrawn during or after the auction period.
4. No complaint about the quantity, quality or condition of the material will be entertained after the auction. The material would be handed over to the highest bidder on “as is where is” basis. The university shall not be responsible for their usefulness or quality.
5. The rights to accept or reject the highest offer finally vests in the registrar of the University.
6. In case of any dispute, the decision of the Vice – Chancellor of the university will be final and binding.

7. The highest bidder shall make his own arrangements for transportation, loading/Unloading and permit etc. if required, after acceptance of his bid. The bidder shall have to pay the local taxes, surcharge or any other tax with the concerned authorities, if applicable, in addition to the amount offered.
8. The security money deposited by the highest bidder be adjusted in the total offered price.
9. The unserviceable material will have to be lifted by the highest bidder within the 15 days after acceptance of the highest bid. Loading and lifting of the auctioned goods shall be done by the purchaser only during the prescribed working hours of the University. No deliveries shall be affected during Sunday or Holidays.
10. In case the highest bidder is unable to lift the material in specified period after acceptance of his highest bid, the total amount deposited alongwith the security money deposit shall be forfeited by the University.
11. Highest bidder will be responsible for any damage done by his labour directly or indirectly at the time of lifting the material.
12. If, sufficient bidders are not participated, the Registrar of the university reserves the right to call for fresh bids. In such an event earnest money deposited by the bidder shall be refunded without interest.
