Note:- For fee of any specific head, the concerned Branch Head/Officer will be invited as a Special Invitee. The proposal regarding fee shall be put up by the concerned Department(s), Branch(s)/Office(s) to the Committee.

Scope:-

Fee collected under any head from the students and affiliated colleges excluding hostel fee etc.

Role & Powers:-

The Fee Committee will recommend the fee structure, bifurcation under different head, fee concession, late fee regulations or any other matter depending upon the situation. Final decision will be taken by the Competent Authority.

The Chairperson(s) of UTDs, Dean, USGS, Principal, University College and Branch Officer(s) will propose the change of fee structure, if any, in the concerned head every year.

The Academic Branch will issue a circular to all the Chairpersons, Dean USGS, Principal, University College, COE, DSW, DYW, Sports Council, NSS & YRC and other concerned branch(s) regarding the revision of fee structure at least three months before the commencement of new Academic Session.
