I am directed to inform you that the examinations of UG & PG courses for terminating semesters/final year are going to start w.e.f. 03.09.2020 and the Date-Sheets have already been circulated to the concerned departments/affiliated colleges.

As per notification/corrigendum issued vide Endst. No. COE/2020/1972 dated 11.06.2020, all concerned are informed that:-

- 1. **Pattern of Question Papers:** The provision of attempting first question as compulsory and selecting one question from each unit by the students has been withdrawn in this examination, as a special case, due to COVID-19 pandemic. The students are allowed to attempt any five questions. Instructions, in this regard, must be given to the students well in advance by the Chairperson(s) of the Department(s)/Principal(s) of the College(s) concerned.
- 2. **Practical Examinations:** The provision of appointment of external examiners for conducting practical examinations of final semester/year by the Chairperson of the Department, as per decision of the Academic Council, has been withdrawn in this examination, as a special case. The practical examinations of final semester/year will be conducted only by internal examiner and the same may be appointed by the concerned Chairperson of the Department/Principal(s) of the College(s). The Departments/Colleges should conduct the examination of their students immediately after theory examinations with a group of 15-20 students. The class teachers/examiners are required to submit awards of practical examinations of the students to the Controller of Examinations of the University through University web portal online on the day of the examinations or latest by 30.09.2020.
- 3. **Sitting Plan:** Sitting plan of the students should be displayed on appropriate place(s) and outside of each examination room. If possible, the same may be circulated on WhatsApp Group of the students well in advance for the convenience of the students and smooth conducting of examinations.

- 4. **Students Strength:** To maintain social distancing, number of students in the examination room/hall has been reduced to 20.
- The Chairpersons of the Departments/Principals of the Colleges, where Examination Centre(s) are created, are required to adhere strictly the guidelines/directions of Ministry of MHRD/UGC/AICTE/NCTE/State Govt./University, *etc.* regarding COVID-19 pandemic.
