"All the Ph.D. registration cases which have been cleared by respective Departmental Research Committees/Boards of Post Graduate Studies and are pending with the Registration and Scholarship Branch, may be processed further on the basis of old Ph.D. Ordinance of Kurukshetra University, for turning down the registration cases at this stage will result into a lot of embarrassment to the University bodies like DRC/PGBOS. Also, the committee opines that the registration cases which might come up in the mean time as recommended by competent bodies may also be considered by the University. These recommendations, if approved, may remain in force till new Ph.D. Ordinance of the University is approved by Academic Council."
