The students opting online mode will have to arrange hardware of required specifications (Desktop/ Laptop/ Mobile with good camera) and high speed internet on its own and is to undertake that he/ she will be responsible for functioning of hardware and internet. No claim will be considered for malfunctioning of hardware/ failure of internet or uploaded blurred (Non Readable) images.
- 7. The student will not be allowed to leave his/ her position in front of camera during tenure of examinations (except during scanning). Any movement or doubt full activity may be considered as Unfair Mean Case (UMC). (All movement will be recorded and monitored with AI enabled system).
- 8. The result of online mode for above courses may be delayed for few days/weeks as that of offline mode.
