"Supply/work order shall be executed within the time specified in the supply/work order which may be extended by the Registrar on the application of the firm/agency indicating the reasonable ground. In the event of the firm/agency failing to execute the work within time, he shall be liable to pay as compensation an amount equal to one percent or such smaller amount as the Registrar may decide on the said amount of the contract maximum 10% of the contract, for every day that the quantity remains incomplete. After the lapse of 15 days beyond the stipulated/extended period it will be the discretion of the University to cancel the supply/work order at risk and cost of the firm/agency/supplier. In case of any other breach of contract/agreement the University will be at liberty to levy a compensation upto 10% of the amount of the contract and may also take any other penal action including the black listing. An appeal against these orders shall, however, lie with the Vice-Chancellor whose decision shall be final".
