- 2. The quotation shall be submitted through post, by hand or E-mail.
- 3. The approximate area to be allotted per tower is 20 ft x 20 ft.
- 4. The minimum rent will be Rs. 15,000/- + GST applicable @ each tower per month.
- 5. Rs. 50,000/- as refundable security for each tower in the form of demand draft will be deposited by the highest bidder at the time of allotment of space for installation of tower.
- 6. The space will be leased out for a period of 20 years and license deed will be for 20 years.
