Notification

An emergent meeting of all the Principals of degree colleges (excluding B.Ed. and Engineering colleges) was held on 18.01.2021 at 3.00 pm in the Committee Room, CV Raman Bhawan (Science Block) under the Chairmanship of the Vice-Chancellor, Ch. Devi Lal University, Sirsa. At the outset, the Dean Academic Affairs welcomed the Hon'ble Vice-Chancellor, Controller of Examinations, Dean of Colleges, Dean Students Welfare, all the Principals and other officers/officials of the university. Thereafter, every member introduced him/herself to the Vice-Chancellor. The Vice-Chancellor shared his vision, mission and national and international academic experience with all the members present in the meeting regarding accreditation etc. After a brief introduction, the agenda items were taken up with the permission of the Vice-Chancellor.

The office of the Vice-Chancellor received letters from the Principals (2) regarding rescheduling the Academic Calendar for the session 2020-21, postponement of theory and practical examinations for the odd semester due to COVID-19 situation and to provide pass percentage to all the colleges. A thorough discussion was held on these agenda items and resolved as under:

1. The academic calendar was issued by the university well in advance in the month of August, 2020 to all the affiliated colleges and the DGHE has also directed all the colleges to start online classes as per time-table vide Memo No. DHE-010019/5/2020-Coordination-DHE dated 30.07.2020 and KW 18179-2020 UNP (4) dated 01.09.2020. The Academic Calendar for the academic session 2020-21 is not required to be rescheduled.
2. Regarding theory examinations of the odd semester, it is unanimously resolved to adhere to the date-sheet provided/notified by the Controller of Examinations.

3. Regarding practical examinations, it was resolved that the colleges may conduct the examinations along with even semester practical examinations. Obviously, the DMCs of odd semester will be issued with the DMCs of even semester.
4. The Controller of Examinations informed the house that pass percentage of each course/semester is being sent to all colleges through e-mail. The Principals will check and verify their record and if still not traceable, they can approach the Controller of Examinations for the same.
5. The university is in the process of curriculum revision according to Learning Outcome Curriculum Framework (LOCF). Therefore, all the Principals may take the feedback of all UG and PG Courses from their teachers and send suggestions to the respective Chairman, Board of Studies/Deans/Chairpersons of the concerned department.
6. All the teachers of the affiliated colleges shall display the internal assessment marks on the Notice Board of the department/college or physically show to the students to avoid any mistake. The college will take all precautions while uploading the internal assessment marks on the University portal.
