4. PG Scholarship for Professional Courses for SC/ST candidates (PGSPROF)

The National Scholarship Portal (<https://scholarships.gov.in/>) was opened for receiving applications on 01.09.2020 with closing date for filing online applications till 30.10.2020. The last date was extended to 30.11.2020 and then it has been further extended upto **20.01.2021**. The guidelines of each scheme are also uploaded on the Portal.
