2 <sup>nd</sup> Counseling	13.11.2020	Fee deposit from 13.11.2020 to 15.11.2020 (upto11:59pm)
3 <sup>rd</sup> Counseling	16.11.2020	Fee deposit from 16.11.2020 & 17.11.2020 (upto11:59pm)
Special Counseling	23.11.2020	Fee deposit from 23.11.2020 to 24.11.2020 (upto11:59pm)
Physical Counseling	27.11.2020	Fee deposit from 27.11.2020 (upto11:59pm)

Note:- List will be uploaded up to 05.00 P.M.

- (i) Admissions up to special counseling will be done online and the candidate is not required to visit the university.
- (ii) Applicants can update his/her result anytime during the admission process, but his/her candidature will be considered for subsequent admission lists only. For example, a candidate updating his/her result between 10.11.2020 to 12.11.2020 will be considered for 2<sup>nd</sup> counseling, a candidate updating his/her result between 13.11.2020 to 15.11.2020 will be considered for 3<sup>rd</sup> counseling, and so on.
- (iii) Department shall update the vacant seats status on 18.11.2020 on the University website.
- (iv) The admission portal will be opened again on 18.11.2020 and applicant can update their result or can submit new application up to 26.11.2020 and these forms/updated result will be considered in the **special/physical** counseling as per availability of seats.
- (v) After physical counseling on 27.11.2020, admissions will be allowed on first-come-first-served basis up to 01.12.2020, after the list prepared on the day of physical counseling is exhausted. Thereafter no admission will be made.
- (vi) The Departments shall upload the list of candidates and configure the course fees online by logging in to their respective interface on the portal.
- (vii) All the candidates including eligible SC students who are exempted from the fees shall have to confirm their admissions using their login details on the concerned portal.

**NOTE:- Admission forms and fees will be accepted through online mode only.**
